PLANNING COMMISSION REGULAR MEETING, SEPTEMBER 4, 1962

MEETING CALLED TO ORDER AT 8:00 P. M. JOHN MOLINO PRESIDING CHAIRMAN.  
OTHER COMMISSIONERS PRESENT: JACK HOLTE, ED OAR, ARCHIE McVAY AND MAYOR  
CAMPBELL. ABSENT: BRYON BRIMM, AL PHILLIPS AND VIRGIL GOLDSBERRY.

MINUTES OF THE LAST REGULAR MEETING HELD AUGUST 7, 1962, WERE READ AND  
APPROVED AS READ.

THE COMMISSIONERS WERE INFORMED THAT ORDINANCE No. 167 (ELECTRIC FRANCHISE)  
HAD BEEN ACCEPTED BY COOS-CURRY ELECTRIC COOP.

A LETTER FROM STATE OF OREGON, STATE HIGHWAY DEPT., WAS READ, STATING THAT  
AN INVESTIGATION WAS BEING MADE, FOR CONSIDERATION OF SIGNALIZATION OF  
HILLSIDE AND OAK STREETS ON CHETCO AVENUE. THE RESULTS OF THIS INVESTIGATION  
ARE EXPECTED TO BE COMPLETED BY THE MIDDLE OF OCTOBER.

BUILDING PERMIT #852, TOGETHER WITH SPECIFICATIONS AND PLANS, WERE SUBMITTED  
ON BEHALF OF HORTON BROTHERS CONSTRUCTION Co., FOR THE ERECTION OF A NEW  
CHURCH BUILDING TO BE LOCATED EASTERLY OF EASY STREET, BETWEEN 1ST AND 2ND.,  
BEING A PART OF TL 2700-41-13-6Bc. OWNERS LISTED AS BOARD OF AMERICAN  
MISSION, AMERICAN LUTHERAN CHURCH. PLANS BY DONALD E. NERAAS, ARCHITECT.  
COST \$41,100.00. IT WAS NOTED THAT THE PROPERTY CONSISTS OF 3 ACRES AND IS  
LOCATED IN AN R-2 ZONE. MAYOR CAMPBELL STATED THAT THE SPECIFICATIONS AND  
PLANS WERE AS REQUIRED BY THE UNIFORM BUILDING CODE.

MOTION BY ARCHIE McVAY THAT BUILDING PERMIT #852 BE ISSUED. SECONDED BY JACK  
HOLTE. MOTION CARRIED.

CHURCH OF NAZARENE (FIFIELD)  
END OF ARNOLD LANE  
SPRUCE AND FERN BEHIND CHETCO HARDWARE  
REDWOOD AND OAK-CATHOLIC CHURCH  
MEMORY LANE BETWEEN TANBARK AND ALDER (AROUND TURN)  
FERN AND RAILROAD  
PINE BETWEEN FERN AND OAK  
PIONEER ROAD (IN FRONT OF LEROY DRAKES)  
BETWEEN EASY AND RANSOM ON 2ND
