REGULAR PLANNING COMMISSION MEETING, JANUARY 4, 1963

MEETING CALLED TO ORDER AT 8:00 P. M.; JOHN MOLINO, PRESIDING CHAIRMAN. OTHER COMMISSIONERS PRESENT: ED OAR, VIRGIL GOLDSBERRY, AL PHILLIPS, BYRON BRIMM, JACK HOLTE, AND ARCHIE McVAY: ALSO IN ATTENDANCE WAS MAYOR ROBERT DIMMICK AND BUILDING INSPECTOR, PERCY HANKS.

MINUTES OF THE REGULAR DECEMBER MEETING AND SPECIAL MEETING, WERE READ AND APPROVED AS READ.

MATTERS OF CORRESPONDENCE, PERTAINING TO INFORMATION RECEIVED REGARDING SCHOOL BUS BUILDING CONSTRUCTION, WERE SUBMITTED TO THE COMMISSIONERS FOR THEIR REVIEW.

REGULAR COUNCIL MINUTES OF DEC. 11, 1962, WERE READ AS A MATTER OF INFORMATION.

JOHN MOLINO GREETED NEWLY ELECTED MAYOR, ROBERT DIMMICK, STATING THAT HE WAS HAPPY TO SEE HIM BACK AS MAYOR AND THAT THE PLANNING COMMISSIONERS WOULD WORK WITH HIM FOR THE CONTINUOUS PROGRESS AND ENHANCEMENT OF THE COMMUNITY.


APPLICATION #865 FOR BUILDING PERMIT WAS SUBMITTED: THE BUILDING INSPECTOR STATED THAT THE PLANS AND SPECIFICATIONS FOR ALTERATION AND REMODELLING ARE IN CONFORMITY WITH THE PROVISIONS OF THE UNIFORM BUILDING CODE.

MOTION BY ARCHIE McVAY THAT THE PLANNING COMMISSION ISSUE PERMIT # 865, CONSTRUCTION AND ALTERATIONS TO BE PERFORMED THEREUNDER TO CONFORM TO THE REQUIREMENTS OF THE UNIFORM BUILDING CODE, AND FURTHERMORE, THAT A SAFETY RAIL BE CONSTRUCTED IN ACCORDANCE WITH THE REQUIREMENTS AND AS DIRECTED AND ACCEPTED BY THE BUILDING INSPECTOR. MOTION SECONDED BY JACK HOLTE. MOTION CARRIED UNANIMOUSLY.

APPLICATION #866 FOR BUILDING PERMIT WAS SUBMITTED: THE BUILDING INSPECTOR STATED THAT THE PLANS AND SPECIFICATIONS CONFORM TO THE PROVISION OF THE UNIFORM BUILDING CODE.

MOTION BY AL PHILLIPS, SECONDED BY VIRGIL GOLDSBERRY THAT BUILDING PERMIT #866 BE ISSUED. MOTION CARRIED UNANIMOUSLY.
