MOTION BY GLENDALE C. HOLTE TO ACCEPT THE RESIGNATION OF GLENN ROGERS AS A MEMBER OF THE PLANNING COMMISSION, SAID TERM ENDING 4/21/65. MOTION SECONDED BY ED OAR. MOTION CARRIED.

VIRGIL GOLDSBERRY, CHAIRMAN REQUESTED THAT THE SECRETARY WRITE A LETTER OF APPRECIATION TO GLENN ROGERS.

LETTER FROM ROBERT A. MATSON REQUESTING THE AUTHORITY TO BUILD A GARAGE AND SHOP FOR HEAVY EQUIPMENT REPAIR, ON PROPERTY LOCATED ONE HALF BLOCK TO THE NORTH OF RANSOM AVENUE OFF 2ND. STREET, WAS REFUSED. THIS PROPERTY IS NOT LOCATED IN THE PROPER ZONING AREA FOR THIS TYPE OF BUSINESS.

MOTION BY ED OAR RECOMMENDING THAT THE PAINT SPRAY BOOTH UNDER CONSTRUCTION LOCATED AT WHARF AND SPRUCE STREETS BE REFERRED BACK TO COUNCIL FOR APPROVAL ON TEMPORARY BASIS, PROVIDING CITY LIABILITY IS NOT ENCURRED. THE PLANNING COMMISSION RECOMMEND IT TO BE REVIEWED BY CITY ATTORNEY, PROVIDING IT BE APPROVED BY FIRE MARSHALL AND CITY BUILDING INSPECTOR. MOTION SECONDED BY GLENDALE C. HOLTE. MOTION CARRIED.
