REGULAR PLANNING COMMISSION MEETING AND PUBLIC HEARING ON PETITION FOR ZONE CHANGE TO ALLOW MOBIL HOME SITE SUBDIVISION WITHIN THE CITY OF BROOKINGS.

CITY OF BROOKINGS OCTOBER 7, 1969

The meeting was called to order at 7:40 p.m. by Chairman Jack Holte.

July, 1969, there were 6 permits issued for the valuation of \$22, 670.
with a fee of \$85. One permit was for a new house. July, 1968, there
were 4 permits issued for the valuation of \$29, 170. and a fee of \$100.50.

August, 1969, there were 6 permits issued for the valuation of \$20,103. and a fee of \$75. One permit was for a new house. August, 1968, there were 7 permits issued for the valuation of \$52,240. and a fee of \$166.50.

September, 1969, there were 5 permits issued for the valuation of \$28,240. and a fee of \$102.00. Two permits were for new houses. September, 1968, there were 4 permits issued for the valuation of \$3,500. and a fee of \$23.

Mr. Fountain brought it to the attention of the Commissioners that the request of Mildred Byrne for zone change from C-l to R-l was approved by the city council and a building permit has been issued.
