2. PRESENTATION OF VAN DUZEE SUBDIVISION FINAL PLAT.

The final plat was presented to the Commissioners for review and discussion followed.

6. RECOMMENDATION NO. 150.

The Building Inspector informed the Commission the fire zone specified for building zone R-H is in conflict with the building code and recommended change.

MOTION by Commissioner Guthrie, seconded by Commissioner Breuer and carried unanimously, to recommend to the City Council that fire zone in R-H zone be changed by the deletion of R-3 from Item 2 in Resolution No. 93, and the addition of R-3 to Item 3 in Resolution No. 93.
