# MINUTES REGULAR MEETING - PLANNING COMMISSION CITY OF BROOKINGS JANUARY 4, 1977

#### PUBLIC HEARINGS:

1. Mr. Dulisse applied for zone change on his property to permit the construction of a two-family dwelling.

2. Mr. John Darjany's request for zone change.

Mr. Don Horton spoke in his behalf. Commission discussed zoning of property along east side of King Street.

After further discussion Commissioner Robinson made MOTION to recommend approval to City Council on zone change request from ML to MG of Tax Lots 2500, 2600, 2700, and 2701, and a recommendation for denial of zone change requested on Tax Lots 2100 and 2000.

Commissioner Renn seconded and Motion carried unanimously.

3. Horton Bros. request for Conditional Use.

Don Horton spoke in favor. In the interest of fire protection Fire Chief Merle Frank spoke regarding burning on this particular site.

After discussion it was MOVED by Commissioner McVay, seconded by Commissioner Renn, and carried unanimously that request for Conditional Use be granted.

The applicant for lot split, Mrs. Crook, was present.

Commissioner McVay made MOTION, Commissioner Renn seconded and it
