## MINUTES BROOKINGS PARKS AND RECREATION COMMISSION February 28, 2008

#### **CALL TO ORDER**

Chair Tony Parrish called the meeting to order at 7:00 pm followed by the Pledge of Allegiance.

#### **ROLL CALL**

*Present:* Commissioners Ken Barkema, Michelle Benoit, Patricia Brown, Frances Hartmann, Don Vilelle & Chair Tony Parrish.

Others present: City Councilor Jan Willms, Public Works Director John Cowan

#### **APPROVAL OF MINUTES**

A. Motion made by Commissioner Brown to approve the minutes of January 24, 2008 as written; motion was seconded and Commission voted, the motion carried unanimously.

#### **PUBLIC APPEARANCES**

Elmo Williams, 1249 Iris Street, Brookings submitted a report and appeared with an update on the building of The Capella in Azalea Park. A volunteer non-profit group to staff, maintain, fund and secure the facility was suggested to be formed. Cameras will be installed to deter vandalism, but vandalism has already occurred and a live-in park presence might reduce this continuing problem. Completion date of the Capella is unknown at this time.

#### **REGULAR AGENDA**

- A. Election of Officers A motion was made by Commissioner Brown to appoint Commissioner Benoit as Chair. The motion was seconded and the Commission voted, the motion carried unanimously. A motion was made by Commissioner Parrish to appoint Commissioner Brown as Vice Chair. The motion was seconded and the Commission voted, the motion carried unanimously.
- B. Azalea Park Planning/Projects Commissioners reviewed the Park and Recreation Commission Agenda Report submitted by City Manager, Gary Milliman. Recommend to add an item 13 Possible park residential caretaker for security purposes. A motion was made by Commissioner Parrish to approve the Azalea Park Planning/Projects outline and send to City Council for further discussion. The motion failed. A motion was made by Commissioner Vilelle to have a joint workshop with the City Council to discuss the Azalea Park Planning/Projects outline. The motion was seconded and the Commission voted, the motion carried unanimously.
- C. Azalea Park Planning/Operations Commissioners reviewed the Park and Recreation Commission Agenda Report submitted by City Manager, Gary Milliman. A motion was made by Commissioner Hartmann to have a combined joint workshop with the City Council to discuss the Azalea Park Planning/Projects outline and the Azalea Park Planning/Operations outline. The motion was seconded and the Commission voted, the motion carried unanimously.

#### **INFORMATION UPDATES/DISCUSSION ITEMS**

A. Parks & Recreation Annual Report – Chair Parrish unable to present slideshow presentation of annual report due to technical problems. A CD is available to view.

- B. Easy Manor Park Update Commissioner Benoit attended a grant writing workshop by the State of Oregon. Deadline for the grant is April 4, 2008. They have developed a task list for members of the subcommittee. It was suggested to improve sustainability points on grants to have a Kans-for-Kids recycling drop location at Easy Manor Park maintained by Loins Club.
- C. Stout Mountain Railway Chair Parrish presented a progress report. Landscaping in the area continues and the signing up of new sponsors. A Golden Spike ceremony is planned during the Azalea Festival. Removal of the hazard trees in Stout Park is being scheduled and replacement trees have been picked out.

#### **COMMISSIONER REPORTS/COMMENTS**

Commissioner Vilelle advised: Natures Coastal Holiday committee will not meet again until August; Azalea Park Foundation did not meet in February; and presented minutes of the January 20, 2008, ball field scheduling meeting attended by Community Recreation Directors.

Commissioner Parrish attended a KASPER program meeting and they are moving along with planning for the summer recreation program.
