Suggested a workshop meeting with user groups of the park to discuss a park use ordinance. Matter continued to discuss with staff workshop scheduling and ordinance process.
- B. Prioritize Park Commissioner's Budget Wish Lists wish list amended.
- C. Stout Mountain Railway Tony Parrish indicated initial meetings of the railway group have shown interest by many in the community, they would like to make a presentation at the next Park & Rec. meeting and discuss more in depth with a public meeting. **Matter continued to next meeting.**
- D. Meet at Azalea Park bandshell for walkthrough at 5 pm on May 1, 2007 for commissioners and staff.
