- Downtown Project: Street paving has been completed; Frontier still needs to underground their lines to facilitate the removal of poles; work is ongoing to solve the water problem in the alley behind the Mazda dealership; streetlights and signs are in the process of being installed. - Bi-Mart: Escrow has been opened on the property; BiMart is assembling a development team to move forward with the Conditional Use Application.

Commissioner comments:

- Commissioner Nachel asked about the status of the Bicycle Grant. Milliman said that it is one of several projects that ODOT is seeking comments on in order to gauge public support prior to making a decision.
