RESOLUTION

BE IT RESOLVED BY THE COMMON COUNCIL OF THE TOWN OF TROUTDALE THAT WHEREAS
THE MULTNOMAH COUNTY BOARD OF COMMISSIONERS DID ON THE 8th DAY OF AUGUST, 1968,
OFFER TO SURRENDER JURISDICTION OVER THAT PARCEL OF LAND HEREINAFTER DESCRIBED
TO THE TOWN OF TROUTDALE, TO-WIT:

That parcel of land that was conveyed to Multnomah County on December 28, 1948
and recorded in Book 1301, Page 15, Deed Records of Multnomah County:

Commencing at the Northeast corner of the recorded plat of Troutdale in Section 25, Township 1 North, Range 3 East, Willamette Meridian, Oregon; thence South 89°35'30" East 162.10 feet; thence South 0°24'30" West 130.00 feet to the most southerly Southeast corner of a certain 2.42 acre tract conveyed to the State of Oregon by deed dated October 8, 1940 and recorded in P.S. Book 579, page 158, Record of Deeds for Multnomah County, Oregon, for the point of beginning of tract to be described and conveyed; running thence South 0°30' West 93.10 feet; thence South 27°57' East 253.50 feet; thence South 39°42' East 145.33 feet more or less to the northwesterly line of that certain tract conveyed by Elgin R. Collins to Albert Welty and Irene E. Welty by deed dated April 1, 1946 and recorded in P.S. Book 1035, page 474, record of deed for Multnomah County, Oregon; thence South 55°49' West on the said line 55.14 feet more or less to the Northeasterly line of County Road No. 917 (Columbia River Highway); thence northwesterly on the said easterly line of County Road No. 917, 524.00 feet more or less to a point which is North 89°35'30" West from the place of beginning; thence South 89°35'30" East 85.00 feet more or less to the place of beginning.

Upon the condition that the Town of Troutdale by appropriate Ordinance or other Municipal Legislation should specifically accept such offer within ninety (90) days from the date of said Order, on the terms and conditions set forth in said Order.

Be it therefore resolved that: The Town of Troutdale does accept such offer of said described property.

Be it further resolved that a copy of this resolution be sent to the Board of County Commissioners for Multnomah County.
