BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF TROUTDALE THAT PORTIONS OF THE FOLLOWING DESCRIBED STREET BE VACATED AS A DEDICATED STREET:

PARCEL NO. 1 :

Beginning at the northwest corner of Lot 6, Block 2 of Fraley Heights Tract, City of Troutdale, Multnomah County, State of Oregon; thence south and east along an arc having a 25 foot radius a distance of 30.77 ft; thence continuing along a circular arc having a radius of 50 ft. a distance of 140.09 ft; to its intersection with the east right-of-way line of Hensley Road; thence northerly along said easterly right-of-way line to the point of beginning; except the westerly 5 foot thereof.

PARCEL NO. 2 :

That certain Section 1 of the Covenants and Restrictions on Lot 30, Fairfax Heights Tract as recorded in Book 926 on Page 1422 known as Supplement, to Declaration of Covenants and Restrictions.

PARCEL NO. 3 :

S.W. 17th Street between Hensley Road and S.W. Clara Street as recorded in Stolls Folly and Fraley Heights Subdivisions.

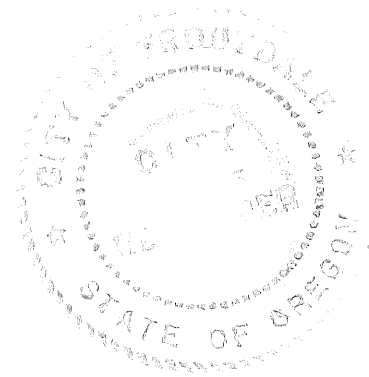
