## COL JIL DISCUSSION MEETING

## February II, 1976

The Mayor called the meeting to order at 8:20 P.M.

Commissioners present: C. E. Finegan, Frank Kaiser, Robt. Dix, Machael Mahoney, Helen Althaus. Absent Commissioner Sam Cox.

Staff present: George Phoenix, Supt. of P/Works, Betty J. Bergstrom, City Recorder.

First item of concern-Press Releases and future procedure. Input as to a workable procedure between City Officials and the press made by:Mr. Lee Irwin-Publisher Outlook, Mr. Bob Martinson and Sharon Mesbit of the Outlook, Council of Troutdale and City Staff.

The Mayor gave a brief background of the policeman dismissal story and possible lack of communication between ourselves and the local press. The Outlook's concern as to the City's method of handling a problem situation whereby involving other press organizations and thereby submitting the City to undue sensationalism. The Outlook's view was they are, and must be responsible for everything that is printed so they must deal in fact and never innuendo.

Future procedure will be to check the Police Daily Log for possible news stories-then inquire on those most newsworthy items from the Chief of Police. In retrospect, it was concluded that the correct procedure was followed by the Chief on the above matter and the Outlook's only objection was the lack of trust by Council in not allowing the Chief to reveal the charges to the press and they would determine what could or legally should be revealed in print.

Miss Althaus was elected to study "rights of privacy" and future implications for the City.

Criss information not to be released nor Grand Jury information released but police call log of factual evidence should be available and police report facts, arrest, or indictment charges be made available.

The Double wall issue was reviewed. The Council is interested in
