AGENDA ITEM # 8 - STREET LIGHTING

Mr. Jean reported at a previous Council Meeting what the cost of street lights would be to the developer. Is the citizen better off by paying higher mortgage at 9% for a 30-year mortgage and resulting in lower taxes or is he better off paying a lower mortgage but a higher tax? The developer could put in stub-outs when they are developing a subdivision, and if the neighborhood wishes lights they can form a lighting district and have standard lights installed. Mr. Jean was directed that the City ask the developer to pay the capital cost of the pole and the light. His argument to that was this was the lowest cost alternative or the best system with a 25' curved light pole. He was asked to look into this as to the economic costs; who is really paying, whether the city pays for it or the developer pays for it. System A is where the City grants at a higher rate and therefore has to tax at a greater rate but the home buyer gets the lower mortgage. System B is to finance at a higher mortgage and be taxed at a lower rate. Present value under A is \$63 compared to \$167 for System B with financing the higher mortgage over 30 years. Assuming the new home buyer would prefer to pay the higher taxes to the City, the City is better off with System A. Mr. Jean recommended we continue with the 25' pole because of its long energy efficiency; also, if subdivision street lighting is required, that the developer be required to pay \$250 per lot based on the 25' standard. Commissioner Kaiser suggested that possibly the home owners in neighborhoods would install house lights in front to help. Mr. Jean recommended to the Council, if they want neighborhood lighting, they go with the \$250 per unit year.

Mr. Muyskens stated that there are 36 lots in Rainbow Ridge. If they are to form a Service District it will cost \$1.86 a month per house for PGE to install the poles, the lights, and furnish the maintenance. Commissioner Weissenfluh likes the Service District style of street lighting.

More discussion followed.

It was the consensus of the Council to go along with System A the least costly. If a developer comes to Mr. Jean and asks about the City Street Light Standards, he can reply with 25' high curved wood pole and System A and give up forming a Street Light District.

Motion moved by Commissioner Kaiser for the standard 25' curved wood pole, Schedule A, and give up forming a Street Light District.
