Meeting called to order at 8:05 P.M.

ROLL CALL

Commissioner Cox moved to appoint Blandine Edwards as acting Mayor  
this meeting.

Duane Lee, Engineer, reported eight bids received and tonight we  
need to award contract and get project underway very soon. Letter  
in your folders of estimates and final engineering estimates (see  
enclosed). Bids most desirable suggested by Engineer as Stadel  
Pump Co. and Wm. Crane Co.

Commissioner Kaiser questioned breaking up bid award into section  
A, Section B, for two contract awards. Mr. Lee endorsed split  
as very workable and productive for City. Commissioner Weissenfluh  
questioned Stadel low bid due to rock estimate, item 5. Mr. Lee  
informed Council bidder would be bound to stick to \$1.00 yard bid  
as well as item 2. His gamble on little rock to move and excavate.  
Commissioner Weissenfluh questioned bid spread being so wide. Mr.  
Lee explained some gamble bid certain items and other have ability  
to bid lower due to union contract, equipment they possess, rental  
usage, etc. Bids very often range widely depending on Company's  
interest in obtaining project.

Discussion by Council on bid totals item by item. Mr. Lee  
explained performance bond required to protect project against change  
orders, overcost, bid changes, etc., but inspector to oversee  
construction and contract will be necessary.

Commissioner Kaiser moved to award Schedule A, Sanitary Sewer portion  
of LID project, to Stadel Pump Co. at bid of \$66,169.75.

Commissioner Kaiser moved to award Schedule B, Storm Sewer portion of  
LID project to William R. Crane Co., at bid of \$14,855.00.

Commissioner Kaiser moved to authorize Mayor to sign awarded contracts  
on behalf of City Council.
