Linda Robinson, of P.S.U. staff, and Sonny Condon, a consultant for P.S.U., presented a report on the County Farm land and land use alternatives for said land. There was some concern and discussion regarding the possible location of a jail on this land, and it was stressed that the report by P.S.U. is not a recommendation for a jail to be located on this site but is rather a recommendation as to the best location within this site <u>if</u> a jail is to be located on this County Farm land. It was also stressed that all of the land use alternatives considered assume no change in existing County facilities. Sonny Condon also stated the most northerly shaded portion of Parcel 3, the property on which the current animal shelter is located, contains a deed restriction stating that the property will revert to the City of Portland if not used for public purposes. Handouts of an outline of the report presented by P.S.U. were distributed by Sonny Condon and Linda Robinson to all those present.

AGENDA ITEM #4, ENGINEER'S REPORT

- 4.3 <u>Well #3:</u> Duane Lee gave oral report based on information contained in monthly Engineer's Report as given to Council and contained in Council packets.
- 4.1 Awarding of Bids Airport Sewer:

Duane Lee stated that the bidding for the various schedules for this project was now completed, and he has reviewed the bids recieved and found two significant errors, one for Schedule B and one for Schedule C.

Regarding Schedule B, the apparent low bidder was Steve Smith for an amount of \$531,999.75; however, a major irregularity occurred in the proposal submitted by Steve Smith. This irregularity involved Item 17, Trench Dewatering. It was the Engineer's recommendation that this bid be rejected on the basis of this irregularity, and that the bid be awarded to the second low bidder, Hannan Bros., in an amount of \$537,997.00. Brian Freeman stated that if Council desires not to accept the low bid it would be appropriate to first make a finding in support of rejection. He stated that after reviewing the statutes it is his opinion that an unbalanced bid and failure to substantially comply with the bid requirements would be justification for rejection of this bid.

Frank Kaiser moved to find a major irregularity in the bid received by Steve Smith based on inconsistencies of the bid in Schedule "B" involving Item 17, trench dewatering, and further moved to reject said bid of Steve Smith and accept the second low bid of Hannan Bros. in an amount of \$537,997.00. Seconded by Dalton Williams.

Regarding Schedule C, the apparent low bidder was Werbin West in an amount of \$84,529.75. The second low bidder was R. T. Robertson in an amount of

\$124,119.00. However, a letter has been received by the City Engineer's from Werbin West stating that they made an error in their bid and indicating in said letter that if the City elects to reject their bid they will relieve the City of any obligation. Duane Lee stated that it was the Engineer's recommendation that the City reject the bid of Werbin West and award the bid to the second lowest bidder. Mr. Fred Werbin and Mr. Dave Werbin, representatives from Werbin West, were both present and confirmed that they did make an error in their bid and would release the City from any obligation associated with said bid if the City elects to reject it.

Helen Althaus moved to reject the bid of Werbin West on Schedule "C". Frank Kaiser seconded.

Helen Althaus moved to withdraw her previous motion and moved to accept the withdrawal of the bid by Werbin West on Schedule "C" as per their request in their letter dated April 8, 1979 and to refund their bid bond. Frank Kaiser seconded.

Page 16, Item 7.4.4.3 - The following sentence should be added at the end of this section: "During the probationary period, vacation credit shall not be awarded until the end of the probationary period."

Page 17, Item 7.4.5.1 - Change this section to read "The City shall encourage curre employees to apply for promotional job vacancies or for lateral moves offerring better promotional opportunities."

Page 18, Item 7.4.9.4 - Add this Section. "Call-back of employees shall be in the reverse order of the lay-off and the employees shall be reinstated as if on a non-paid leave status during the layoff.

Page 27, Item 7.6.1.5 - Insert the word regular before holiday pay in the second to last sentence.
