Mayor Thalhofer called the meeting to order at 7:00 p.m. and called on Councilor Daoust to lead the Pledge of Allegiance.

Mayor Thalhofer read Years of Service Certificates for several employees, Jerry Ortega was present to receive his.

4. PUBLIC COMMENT:

Mayor Thalhofer called this item.

Roman York and Gail Thurber, read a letter of complaint into the record regarding the SE Dora Project and the way staff has handled it, requested an independent investigation. (Letter contained in Council Packet)

Mayor Thalhofer stated he would take their request under advisement.

5. PUBLIC HEARING/APPEAL: An Appeal of the Planning Commission decision in the matter of Case File 98-013, Expansion of the Columbia Gorge RV Park Conditional Use.

Mayor Thalhofer called this item, recessed the Council Meeting and opened the public hearing at 7:25 p.m., then read the public hearing procedure.

Councilor Kight stated that he owns a piece of property that received notice of this Conditional Use, but the property would not be adversely affected so there is no conflict of interest, also stated that he has pictures of the affected property.

Faith requested that any evidence be held until the type of hearing is determined, and explained the options, On the Record, or De Novo. In the past this type of hearing has been held De Novo.

Mayor Thalhofer stated that he would prefer to stay with past practice and have the hearing De Novo.

Councilor Daoust stated that the final order points out that there is so much information missing about the project in the application that he would favor De Novo so that the applicant can reply to the Final Order.

MOTION: Councilor Ripma moved to hold the hearing De Novo. Councilor Kight seconded the motion.

YEAS: 7 NAYS: 0 ABSTAINED: 0

McCallum presented the staff report contained in the packet.

Councilor Kight asked if the applicant had replied to the Findings of Fact or Final Order from the Planning Commission?

McCallum stated that she believed the applicant would be doing that this evening.

Councilor Ripma asked how much fill had been brought onto the site?

Faith stated that the applicant claims they have brought on 20 dump truck loads, about 1 inch, but after walking the site it appears there is considerably more than 1 inch in some areas.

Councilor Daoust asked how the flood plane is determined?

Faith explained by using the Federal Flood Insurance Rate Map.

Councilor Daoust asked how the wetlands were identified?

McCallum replied that the Oregon Division of State Lands identified the wetlands.

Councilor Kight presented photos of the wetland areas on the site in question and stated that these areas were under water during the February 1996 flooding.

D J Bleu, and Ted Copher, applicant, submitted and presented material (Contained in Packet) addressing the Planning Commission Final Order and Findings of Fact. Strongly disagreed with the Federal Flood Insurance Map and Indicated that FEMA would support their claim that the map is not accurate at each specific site, it is used for general vicinity purposes. They had a survey done that shows a different elevation that would put them out of the flood plain.

Mayor Thalhofer called for a break at 8:37 p.m. and reconvened the public hearing at 8:52 p.m.

Council discussed the material submitted by Bleu and Copher addressing the issues raised by the Planning Commission.

Council discussed the flood plane and the surveys that had been performed and determined that no action could be taken until the letter that Mr. Bleu and Mr. Copher stated that FEMA would send regarding this issue was received.

Council reached consensus to set this issue aside to a time uncertain and directed staff to place this back on the agenda when Mr. Copher and Mr. Bleu received the letter from FEMA.

Copher had no objection to setting this issue to a time uncertain.

6. PUBLIC HEARING/ORDINANCE INTRODUCTION: An Ordinance amending Section 12.07.010 of the Troutdale Municipal Code to prohibit the discharge of wastewater that is contaminated with any detectable amount of dry cleaning solvent to the sanitary sewer system.

Andre Molnar, Molnar Group, stated that he was disappointed that the Molnar Group was not selected tonight but he felt the Council is doing the right thing.
