Meeting was called to order at 7:03 p.m. by Mayor Thalhofer.

#### 6. PRESENTATION: State of the City

Mayor Thalhofer read the State of the City contained in the packet.

#### 7. PUBLIC COMMENT

Mayor Thalhofer called this item and asked if their was anyone here who would like to speak to us on a non-agenda item.

There was no public comment.

8. PUBLIC HEARING / ORDINANCE (Introduced 12/8/98): An Ordinance vacating a pedestrian accessway within Eldon Snider Farms Estate Subdivision and authorizing its conveyance to adjoining property owners.

Mayor Thalhofer called this item, recessed the City Council Meeting and Opened the Public Hearing at 7:30pm and asked Mr. Faith to come forward.

Faith reviewed the staff report contained in the packet.

Councilor Kight stated I noticed in the conditions that the property that is going to be transferred to the property owner, that they are going to cover the cost of the easement as well as the preparation of the documents and maps, however there is no mention of a survey. Wouldn't a new survey be required to find the new property corners?

Faith replied I don't believe a survey would be required because the description of the property is as it appears on the face of the plat.

Councilor Kight stated I was thinking in terms of protecting the property owners. I would think in the course of this procedure that they would want to have a new survey done.

Faith replied if I were in their shoes I wouldn't.

Councilor Rabe asked we did establish that there was a six inch waterline?

Faith replied that is correct.

Councilor Rabe stated the City wants to maintain access for maintenance to the pipe, are there going to be any conditions imposed on those individuals so that the City can gain access to the pipe. If they want to put a permanent fence in then the fence may have to come out, who would incur the cost of removal and replacement of the fence?

Faith replied that could be spelled out in the document and in the easement. If we have an

easement that guarantees us access to that site then the property owners would have the responsibility to remove the fence at their cost.

Mayor Thalhofer closed the Public Hearing and reconvened the City Council Meeting at 7:36pm.

Mayor Thalhofer called this item.

Councilor Kight stated that the average daily fluent for the month is at 1.9 million gallons, I thought we were going to top out at 1.4. Are we over the mark or am I reading this wrong?

Galloway replied the figure is correct. We had a pretty wet month of December. Even though we did get flows heavier then the plant is designed to accommodate, we did not have any problem getting a permit.

Councilor Rabe asked in regards to Harlow Canyon Drainage, where the creek drains into the conduit, is the grate being looked at to the extent if it were to become plugged it wouldn't result in a back flow that occurred previously?

Galloway replied the waste water folks who handle both the storm water and the sanitary sewage do have that on their work plan to check, I believe it is once a week.

Councilor Daoust asked why would the Oregon Department of Fish and Wildlife not like the step pools that are behind the Harlow House?

Galloway replied we don't have a definitive answer to that. That is why we are trying to set up a meeting with the parties involved to go over that.

Councilor Daoust asked we were planning on spending money to repaint that water tank along Stark Street, are we looking at a very large cost for lead paint abatement? Was that planned originally or is that an additional cost?

Galloway replied I don't have a good feel for that. The only figure we had, which appears in this years budget, is \$85,000. That was provided to us by a contractor, whether or not he included the lead paint issue or not, I don't know the answer to that.

Councilor Kight stated a follow-up question on the Harlow Canyon Drainage, I noticed that the Division of State Lands one of their proposals is that you add another detention basin up at the top of the Canyon. Are we talking back up a Strawberry Meadows at the subdivision?

Galloway replied I think their idea was to do something prior to water getting into Beaver Creek. Their written response was very vague that is why we are trying to meet with them.

Councilor Rabe asked I have a question in regards to Harlow Canyon and the repair of the trail. Are you just hoping that possibly with the permission from DSL and ODFW that the trail will also come in as a package to get fixed?

Galloway replied if we get permission to go in and do some work, restoration of the trail would be part of that.

Councilor Rabe stated I have had quite a bit of dialog with the Mid County Lighting District about the type of lamps they are putting in the street lights. The White glare lamps are not allegedly suppose to be in there, we are all suppose to have the amber lamps. Do you know anything about this?

Galloway replied I am not aware of that.

Councilor Kight asked when the City puts in street lights do we specify if they are white or amber?

Galloway replied I don't think there is one answer. In general most of the street lights that have gone in the City have been put in as part of a development, usually a residential subdivision. Typically the developer or the developer's engineer designs the street lighting system and gets a buy-off from the Mid County Lighting District and PGE or they turn to the lighting district or PGE and contract with them to do the design. There is an ultimate sign off by the lighting district and PGE. Whether they restrict them to one particular bulb type or not I don't have that answer.

Councilor Kight asked could we check with PGE and find out if we have that option available.

Galloway replied I could look into whether there is an option but it sounds as if Councilor Rabe has already done that.
