Dear Ms. Matzke.

I am writing on behalf of the Northwest Sport Fishing Industry Association to urge the DEQ to adopt the proposed human health criteria for water quality based on a fish consumption rate of 175 grams per day. Moving to this standard recognizes the need to reduce the contaminants found in Oregon's waters. These contaminants affect the health of our fish and ultimately have effects on the health of people who consume them.

Sport fishing is a major activity in Oregon. It provides countless hours of recreation and it is the basis for a large sport fishing industry that provides jobs and income essential to the economy of our state. This change to a stricter standard will move the state forward toward the reduction of risk to both fish and people.

We understand that the proposed standards have been developed in cooperation with the Environmental Protection Agency and with the involvement of key stakeholders. We think the process used has been sound and that the recommendations are valid efforts to make progress in cleaning up our natural environment. This issue is of particular interest to the Indian Tribes of the state since their members rely on wild caught fish for a substantial source of food. Many who sport fish in Oregon regularly consume their catch as well. Strengthening the current standards will reduce the health risks of these fish consumers. We know Oregon Tribes are in support of the proposed regulations and we concur with their recommendations.

Strengthening the consumption standard is beneficial to our organization because it will assure the continued benefits of active sport fishing in our state and therefore the continued vitality of our business activity. Again, protecting the safety of fish from Oregon waters protects aquatic health, human health and the health of an industry that employs nearly 11,000 in this state, generating a billion dollars in economic benefitsⁱ. We feel these standards will be a sound investment in Oregon's future.
