- 2. Why is "Notices of Violations" still in the definition for FEA? NOV doesn't appear anywhere else in the document.
- 3. For the definition of PEN can you add the word "informal" before "written notice"?

Also, it seems like you will have a lot more FEA's needing to be posted in the air database. Have you talked with Cindy about what the changes to the definition will mean for data entry into AFS?

If a notice of permit violation is for a Class 1 violations why isn't it an FEA? Is it just that it doesn't carry a penalty?

Under the factor for adjusting the penalty, specifically "C" respondent's effort to correct violation...(b) it should say made not make.
