With exception of Steve Mrazik for 401 dredge/fill, I am assuming that you do not know about the revisions as well because the response I received Jeff Bachman indicated that these changes were agreed to by HQ-WQ managers. What I need from you: I believe the revisions will have ramifications on how you conduct enforcement actions in your regions so please quickly review the very brief list below. The stormwater managers are scheduled to talk about changes to Div. 12 this afternoon (the reclass of failure to implement all stormwater plans to Class I) but a couple of other questions have come up that I would like to be able to answer for them:

## 1) The NPDES 1200-C and 700PM violations and have been moved up in the matrix. Where/who did that come from?

Les thought there should be a hierarchy of stormwater/turbidity violations with the four types of sources divided between the 4 matrices ( $1200C \ge 5$  acres on the \$12,000, 1200C < 5 acres on the \$8,000; < 1 acre non residential on the \$3,000; and < 1 acre residential on the \$1,000. It was decided by OCE that we should propose raising the 700 PMs from the \$1,000 to the \$3,000. We talked with Denny Ades and Jim Billings and they agreed.

340-012-0140(2)(A)(e)(iv) and (v) – was "major" dropped from the revisions on purpose? In other parts of the rule it was changed to "Tier 1" so I would expect the same for these revisions. I worked with Beth Moore to make the language consistent with our rules. Who we are trying to capture is better described by the individual vs. general permit descriptors rather than Tier 1 and Tier 2

(This the classification of WPCF and NPDES individual "major" food processing permits in the highest matrix (\$8,000 matrix which has been increased to \$12,000). The new proposed language drops "major" to include all individual permits.)

3) I did not hear from the 401 cert managers about the new 401 certification matrix classifications. Where/who did those come from?

Denny Ades (Marilyn Fonseca) for the hydros and Steve Mrazik, after consulting with the other dredge and fill folks, for the dredge and fill 401s.
