ORDINANCE NUMBER

AN ORDINANCE CONFIRMING ASSESSMENT ROLL NEEDER SIX(3) AND DIRECT-ING THE SAME TO BE SPREAD UPON THE DOCKET OF THE CITY LIENS AND COLLECTED, AND DECLARING AN EMERGENCY.

WHEREAS, heretofore and to-wit, on the <u>fit</u> day of <u>July</u>, 1922, the City Commission of the City of Warrenton passed a Resolution declaring its intention of improving Wheeler Street from Portland Avenue to Pacific Avenue, and Pacific Avenue from Wheeler Street to the Dyke Line on the East bank of the Skipanon River, by macadamizing the same along the center thereof, and

WHEREAS, the costs and expenses of making said improvement , together with all incidental expenses connected therewith amount to Fifty-eight Hundred Forty-six Dollars and Nineteen Cents(\$5846.19) and that the said costs and expenses of making said improvement are appraised and assessed against the property in said district.

NOW THEREFORE

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:-

SECTION -1-

That the assessment roll, made and prepared by V. H.Coffey E. H. Flagg and E. S. Hamel, covering the costs and expenses of improving district number Six (6) in the sum of Fifty-eight Hundred Forty-six Dollars and Hineteen Cents (\$5846.19), the making of said improvement c ensisting of the improvement of Wheeler Street from Portland Avenue to Pacific Avenue, and Pacific Avenue from Wheeler Street to the Dyke Line on the East bank of the Skipanon River; by macadamizing the same along the center ther of, and that the costs and expenses of making said improvement, together with all incidental expenses therewith amount to the sum of Fifty-eight Hundred Fortysix Dollars and Nineteen Cents (\$5846.19), and that the costs and expenses of making said improvement have been appraised and assessed to the following properties in the amount set opposite to each described lot as follows:-
