## **Introduced by All Commissioners**

## APPROVING AND AUTHORIZING A LOAN TO THE WASTEWATER FACILITY GO **BOND FUND FROM THE SEWER FUND**

Whereas, ORS 294.460 authorizes municipal entities to loan money from one entity to another by resolution, and

Whereas, there is a need to pay the debt service on the General Obligation Bonds issued to construct a new Wastewater Treatment Facility, and

Whereas, the property tax levied on July 1, 2007 is insufficient to meet the scheduled payment on June 1, 2008, and

Whereas, there is a deficiency of approximately \$18,000, and

Whereas, the Wastewater Facility GO Bond Fund will repay the principal of \$18,000 plus interest of 5% (\$900), for a total repayment of \$18,900, in fiscal year ending June 30, 2009, and

Whereas, the levy on July 1, 2008 will include \$18,900 of additional debt service to repay the loan from the Sewer Fund,

BE IT RESOLVED that the City Commission of the City of Warrenton hereby authorizes an interest bearing loan in the principal amount of \$18,000 from the Sewer Fund to the Wastewater Facility GO Bond Fund.
