ORDINANCE NO. 1152-A

Introduced by Commissioner: Terry Ferguson

An Ordinance Amending Ordinance No. 1147-A, Section 3, Installation and Maintenance of New Service

The City of Warrenton Ordains as follows:

Section 1. Section 3 of Ordinance No. 1147-A is amended to read as follows:

Section 3. INSTALLATION AND MAINTENANCE

1. Installation: A new service may be installed upon application and payment of the current water tap fee. Upon payment thereof, the water department will furnish all labor and materials necessary for such installation. All meters shall be installed only in the public right-of-way adjacent to: (1) the property to be served, or (2) a recorded easement which allows placement of utilities, which easement benefits the property to be served.

Section 2. This Ordinance shall take effect 30 days after its passage.
