O)RDINANCE NOS XX 36A

AN ORDINANCE ACCEPTING THE IMPROVEMENT OF PARTS OF THIRD STREET, WARRENTON OREGON, ADD DIRECTING THAT ASSESSMENTS BE MADE UPON THE PROPERTY THEREBY BENEFITED TO DEFRAY THE EXPENSE OF SUCH IMPROMEMENT, AND DECLARING AN EMERGENCY,

WHEREAS, The finner City Commission having heretofore, by ordinance authorized and directed the improvement of portions of Third Street des-cribed as follows, Beginning on Third Street at its Intersection with the hard surfece pavement on Main Street Thense running Eastward along the Sou South side of the Railroad Spur, continuing along said spur on Third Street to the Intersection frof Third Street with the Planked Roadway on Hemlock Street.and being in the City of Warrenton, Clatsop Openty, Oregon; - said improvement being made in the following described manner, towit: -

AND WHEREAS, said improvement having been made completed in accordance with said ordinance and the plans and specifications therefor, and a certificate of completion of said improvement having been signed by the Committee on Streets and Public Highways, and heretofore filled with the Auditor and Police Judge.approving said improvement, from which it appears that the aggreate expense of said improvement is \$610,35, and

WHEREAS.It is neccessary that assessments be made and levied against the real property benefited by said improvement, for the purpose of raising a special fund with which to defray the expenses Of making said improvement. Now, therefore

The City of Warrenton does ordain as follows. SECTION 1, That the board of appraisers consisting of George Schmidt Geo, A, McGuire, and R, D, Kelsombe, and hereby is.authorized and directed to assess the hereinafter described property, in accordance with the benefits accruing to the same from said improvement, in the aggreate sum of \$610.35 the property to be so assessed and included in a special assessment Distr-ict being particularly described as follows to wit;-Lots 1-2-3-4-13-14-15-;16-in Block (8) and Lots 4-5-6-7-8-9-10- in Block

(2) all in-Warrenton Addition to Astoria, Oregon, as laid out and platted by D,K, Warren

SECTION.22. That said Board of Assessers, in making said assessment as afore-said.shall make out a list of said lots, lands and premesis, by proper desce ription, giving the valuation of each lot or parcel, of land, respectfully. wit with the name or names of the reputed owners or owners, and shall levy the eonthe amount to be assessed, in the manner provided in this Ordinance and the Charter of the City of Warrenton, and when said assessment shall be com-pleted, it shall report the same to the Commission, at its next regular meet-ing ing, if practicable, and if not, then as soon thereafter as may be practticable.

SECTION 3 That the enactment of this Ordinance at this time, and the making effect of the same forthwith, it is neccessaru for the immediate preserva-tion of the public peace, health and safety of the inhabitants of the City of Warrenton, and, therefore, an emergency is hereby daclared to exist, and th this Ordinance shall be in full force and effect, upon its passage by the Commission and approval by the Mayor of said City,
