An Ordinance authorizing, directing and empowering the Mayor and Auditor and Police Judge of the dity of Warrenton, to issue "Improvement Bonds" of the dity of Warrenton, upon the "Special Improvement District " ereated on the <u>6th</u>, <u>day of March</u>, 1923 for the purpose of defraying the costs and expenses of improving Wheeler Street and Pacific Ave, by building thereon a Macadam Roadway, from the intersection of Wheeler St, with Albany Ave, thence North along center of Wheeler St to its intersectin with Pacivic Ave, thence west along Pacific Ave to the Skipanon River The said streets passing over the First Extension to in the wity of Warrenton, also known as "District Number <u>6</u>,".

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS: Section 1;- That the Mayor and Auditor and Police Judge of the City of Warrenton be and they are hereby authorized, directed and empowered to issue "Improvement Bonds" of the city of Warrenton, in the sum of xxxxxxx \$5501.19 , upon the "Special Improvement District" created on the 6th day of March ,1923 for the purpose of

defraying the costs and exponses of improving Wheeler Street and Pacific Ave.by building thereon a Macadam Roadway. from the intersection of Wheeler st, with Albany ave, thence Nowth along center of Wheeler street to its intersection with Pacific Ave, thence west along Pacific Avenue to the Skipanon River, Said streets passing over Fist Extension to East Warrenton, and P rtoria Extension to Warr nton in the dity of Warrenton, also known as "District Number____6____".

Section 2:- That said bonds shall be issued in convenient denominations not exceeding Five Hundred Dollars each, and in all equal to the total of amount/unpaid assessments for said improvement; said bonds shall mature in ten years from date of issue and shall bear interest not to exceed six per cent per annum, interest payable semi-annually, the said interest shall be evidenced by coupons attached to said bonds; provided, the right to take up and cancel such bonds or bonds upon the payment of the face value thereof with accured interest to the date of payment, at any semiannually coupon period at, or after one year from the date of such bond or bonds, shall be, and hereby is, vested in the City of Warrenton, all in accordance with Section ten, chapter six of the charter of the city bf Warrenton, which said chapter and Section is hereby referred to and made a part hereof as though set out in full in this ordinance.

Section 3; - That said bond or bonds when issued as herein provided may be delivered to the contractor by the City of Warrenton, in payment, at par, upon the contract for the improvement as hereinbefore specified, provided, however, that before said bond or bonds are delivered to the contractor as herein provided, special fund warrants if any, have been issued to the contractor in payment for making said improvement must before delivery to the contractor of said bonds be returned and surrendered to the city of Warrenton, and bond or bonds issued under authority of this ordinance is (are) issued in lieu of such "special fund Warrants". Section 4; - That the Mayor and Auditor and Police Judge of the

City of Warrenton be and they are hereby authorized and directed to cause said bond or bonds to be issued and to affix their signatures as Mayor and Auditor and Police Judge respectively to each of said bonds and coupons attached thereto.
