An ordinance prohibiting the interfering with and (or) driving over fire hose when in use at fires or fire drills; prohibiting motor vehicles from following fire apparatus when going to a fire, closer than 300 feet, providing right-of-way for all fire apparatus when going to a fire, regulating traffic from the sounding of an alarm of fire, providing a penalty for the violation of this ordinance, repealing all ordinances or parts of ordinances in conflict with this ordinance and declaring an emergency.

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS .

Section 1. That interfering with and (or) driving over fire hose of the City of Warrenton, when in use at fire's or fire drills be and the same is hereby prohibited.

Section 2. All motor vehicles are hereby prohibited from following fire apparatus and (or) fire department vehicles of the City of Warrenton, when said fire apparatus and (or) fire department vehicles are going to a fire and (or) resp\$onding to an alarm of fire closer than 300 feet to said fire apparatus and (or) fire department vehicles of the said city of Warrenton.

Section 3. That the fire department apparatus and (or) fire department vehicles of the City of Warrenton when going to a fire and (or) responding to an alarm of fire shall have right-of-way over all other vehicles, and all traffic shall at the sounding of an alarm of fire drive to the right side of the road and stop until the fire apparatus and (or) fire department vehicles has passed, and so as to afford free passage of fire department apparatus and right-of-way to same. Section 4. Any person or persons,firm or corporation,violating any of the provisions of this ordinance shall,upon conviction thereof,before the Auditor and Police Judge of the City of Warrenton,Oregon,be punished by a fine of not less than five (\$5,00) Dollars or more than One hundred (\$100,00) Dollars,or by imprisonment in the City Jail not less than two or more than fifty days,or by both such fine and imprisonment.

Section 5. That all ordinances or parts of ordinance in conflict xx with this ordinance be and the same are herewith repealed.

Section 6. Inasmuch as the objects of this ordinance will be of great benefit to the people of the City of Warrenton and there exists and is an urgent necessity that this ordinance should take effect as soon as possible so that the health, peace and safety of the people of the City of Warrenton may be preserved, and so as to protect life and property within the City of Warrenton from the ravages of fire, an emergency is hereby declared to exist and this section therefor shall take effect when adopted by the affirmative vate of the commission of the City of Warrenton, and this ordinance shall then take effect and become operative immediately upon its passage and approval by the Mayor of the City of Warrenton.
