

1 An ordinance vacating that certain portion of "Hays street,
2 from the south line of Columbia Avenue to the North line of Pacific
3 Avenue, and that portion of Arthur street, from the north line of
4 Marshall Avenue, to the south line of Tonquin Avenue, in the City of
5 Warrenton, Clatsop County, State of Oregon, and declaring an emergency.

7 Whereas, a petition signed by the owners of all of the property
8 abutting on Hays street from the south line of Columbia avenue,
9 to the north line of Pacific avenue and abutting on Arthur street,
10 from the north line of Marshall avenue to the south line of
11 Tonquin avenue, on each side of said streets between the points
12 hereinabove designated, has been filed with the City of Warrenton,
13 asking that said streets between the said points be vacated, and

14 WHEREAS, the Commission of the City of Warrenton, after carefully
15 considering the said petition deem and consider it for the best
16 interest of the city of Warrenton that said streets be vacated as
17 petitioned for, and that the signers of the said petition, to vacate
18 said streets, comprise all of the persons who will be affected by
19 such vacation, Now therefore; -

20 THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

21 Section 1; - That Hays street from the south line of Columbia Avenue
22 to the north line of Pacific Avenue in that part of the city of
23 Warrenton, Oregon, known as "Portoria Addition" to Warrenton, be and
24 the said street is hereby vacated between said points as a public
25 street.

26 Section 2; - That Arthur street from the north line of Marshall
27 avenue to the south line of Tonquin avenue in that part of the City
28 of Warrenton, Oregon, known as Portoria Addition to Warrenton, be and
29 said street is hereby vacated between said points as a public
30 street.

31 ~~Section 3; Inasmuch as the objects to be obtained by this ordinance~~
32 ~~will be of great benefit to the people of the city of Warrenton,~~
33 ~~and there exists and is an urgent necessity that this ordinance~~
34 ~~should take effect as soon as possible so that the industrial~~

1 advancement of the city of Warrenton may be promoted, and so
2 that the health, peace and safety of the city of Warrenton
3 may be preserved an emergency is hereby declared to exist and
4 this section therefor shall take effect when approved by ~~the~~
5 the affirmative vote of all the members of the commission and
6 this ordinance shall then be in full force and effect and
7 operative immediately after its passage and approval by the
8 Mayor of the city of Warrenton.
