AN ORDINANCE PROVIDING FOR THE LEVY AND COLLECTION OF A SPECIAL TAX OF // MILLS UPON ALL THE ASSESSABLE PROPERTY IN THE CITY OF WARREN TON, OREGON, FOR THE SPECIFIC PURPOSE OF APPROPRIATING THE SAME TO THE USES AND PURPOSES OF THE WATER COMMISSION OF THE CITY OF WARRENTON TO THE END THAT SAID COMMISSION SHALL MAKE A PRELIMINARY SURVEY AND INVESTIGATION OF THE WARREN SUPPLY OF THE CITY OF WARREN-TON, TO PROVIDE PLANS FOR A BETTER WATER SYSTEM, AND TO ALSO IN-VESTIGATE AND PROVIDE PLANS FOR A MUNICIPAL ELECTRIC LIGHT PLANT AND SYSTEM.

The City of Warrenton does ordain as follows:

The people of the City of Warrenton do ordain as follows: SECTION I: That for the purpose of making a preliminary investigation and survey of the territory adjacent to the City of Warrenton to the end that an adequate and suitable supply of water may be secured and brought into said municipality for all domestic and municipal purposes, and to provide plans for such a municipal water system, and also for the purpose of making a preliminary investigation and survey of the question of establishing a municipal light plant in and for said City of Warrenton, and for all kindred purposes allied to these two main propositions, and for the purpose of generally carrying out the objects of this ordinance. a special tax of / mills is hereby made and levied upon all the assessable and taxable property within the City of Warrenton, both real and personal, which is taxable by law for state and county. purposes; which said special tax of / mills shall be collected in the manner provided by law for the collection of other municipal and county taxes.

SECTION II: That when said tax is collected the same shall, in its entirety, be turned over to the water commission of the City of Warrenton, for the uses and purposes herein set forth and indicated; and it is hereby made the duty of said water commission to make
the investigations and surveys hereinbefore mentioned in Section
I of this ordinance, and to utilize and apply any or all of said
fund to the investigations and surveys aforesaid, and for the upor dight plant or both.
building and betterment of the water system of the City of Warrenton.

SECTION III: It shall be the duty of said water commission to keep strict account of said special fund, and to make detailed report unto the Common Council of the City of Warrenton at the commencement of each fiscal year of the manner in which said moneys have been expended, and of the results therefrom obtained.
