ORDINANCE NO. 163

An ordinance vacating a certain portion of the plat of Second Extension of Warrenton in Clatsop County, State of Oregon, consisting of all of Blocks (and the lots included therein) numbered One (1) to Ten (10) inclusive, Nineteen (19) to Thirty-eight (38) inclusive, Fiftyeight (58) to Seventy-seven (77) inclusive, and Ninety-six (96), Ninetyseven (97), Ninety-eight (98) and One Hundred Sixteen (116); and certain portions as hereinafter described, of Elm, Date, Cedar, North Main, Palm, Laurel, Linden, Beach and Front Streets, and Harrison, VanBuren, Jackson, Monroe, Madison, Jefferson, Adams and Washington Avenues, all in said Second Extension of Warrenton.

WHEREAS, on the 26th day of April, 1915 Fred L. Warren and Charles R. Higgins, Trustees under the Last Will and Testament of D. K. Warren, deceased, and Sarah E. Warren, George W. Warren, Florence E. Warren, Lucy A. Thompson, H. C. Thompson, Fred L. Warren, Ruth Warren, Minnie M. Higgins and Charles R. Higgins filed with the auditor of the city of Warrenton in Clatsop County, State of Oregon, a petition for the vacation of that certain portion of the plat of Second Extension of Warrenton, an addition to the city of Warrenton in Clatsop County, State of Oregon, described in the said petition and herein described, and

WHEREAS, due notice was given by advertisement for thirty consecutive days in The Warrenton News, a public weekly newspaper printed in the said city of Warrenton (the first publication of said notice being in the issue of April 29, 1915 of said newspaper and the last publication of said notice being in the issue of June 3, 1915 of said newspaper); that on the 26th day of April, 1915 the said petitioners filed with the auditor of the said city of Warrenton the said petition praying for the vacation as aforesaid, and that the said petition praying for the said vacation would be presented to the common council of the said city of Warrenton for its consideration at a regular meeting of the said council to be held on Monday the 7th day of June, 1915, which notice, with due proof of its publication subscribed and sworn to by E. H. Flagg the printer of the said The Warrenton News, has been filed with the auditor of the said city of Warrenton, and

WHEREAS, the said petition was duly advertised and presented to said council on the date named in said notice, and within named, which

petition duly set forth the particular circumstances of the case and the reason for said vacation and a distinct description of the property to be vacated and the names of the persons to be particularly affected thereby, and to which petition there was appended as a part thereof the written consent, duly acknowledged before a Notary Public in and for the State of Oregon, of the owners in fee simple of all the property immediately adjoining or fronting on both sides of each and all the streets and avenues proposed in said petition to be vacated and of all the property contained in the said portion of the plat of said Second Extension of Warrenton proposed in said petition to be vacated and of all the property that would be particularly affected by such vacation, and

WHEREAS, said petition was duly called and presented to the common council of the said city of Warrenton at the regular meeting of said council held on Menday the 7th day of June, 1915, and

WHEREAS, the said petition was not considered at said meeting but was duly postponed to the next meeting of the council, and the consideration of the said petition has been duly postponed from meeting to meeting since the said date of June 7, 1915, and

WHEREAS, no objections to said petition or the granting thereof or to the vacation prayed for have been filed, and

WHEREAS, said council has ascertained and determined and does hereby cause it to be made a matter of record that the written consent, duly acknowledged before a Notary Public in and for the State of Oregon, of the owners in fee simple of all the property immediately adjoining or fronting on both sides of each and all the streets and avenues proposed in said petition to be vacated and of all the property contained in the said portion of the plat of said Second Extension of Warrenton proposed in said petition to be vacated and of all the property that would be particularly affected by such vacation, has been duly obtained and that the public interest will not be prejudiced by the said vacation prayed for and that the charter and ordinances of the city of Warrenton

pertaining to the vacation of streets and plats have in all respects been fully complied with,

NOW THEREFORE, the City of Warrenton does ordain as follows: Section 1- That all of the following described portion of the map or plat of Second Extension of Warrenton, an addition to the city of Warrenton in Clatsop County, State of Oregon, as the said Second Extension of Warrenton was laid out and platted by D. K. Warren and wife, to-wit:

Beginning at the most Northerly corner of Block 10 in said Second Extension of Warrenton, running thence Northeasterly on a continuation Mortheasterly of the Southeasterly line of Walnut Street in said addition to a point in the Northeasterly line of Said addition, being also the Northeasterly along the Northeasterly line of said addition; running thence Southeasterly along the Northeasterly line of said addition; thence Southwesterly along the Northeasterly line of said addition; thence Southwesterly along the Southeasterly line of said addition, being also along the Southeasterly line of Blocks 1, 28, 29, 67 and 68 in said addition to the Southwesterly termination of said line, being also the Southeasterly termination of the Southwesterly line of Jefferson Avenue in said addition; thence Northwesterly along the Southwesterly line of said Jefferson Avenue to a point in the Southwesterly line of Date Street in said addition; thence Northwesterly along the Southeasterly line of. said Date Street to a point in the Northeasterly line of Ist Street in said addition; thence Northwesterly along the Northeasterly line of. Harold Street in said addition; thence Northerly of the Easterly line of. Southerly of the Easterly line of said Harold Street and along the Easterly line of said Harold Street, being also along the Westerly line of Blocks 116, 98, 96 and 77 in said addition, to a point in the Southeasterly line of said Walnut Street; thence Northeasterly along the Southeasterly line of said Walnut Street; and being also along the Northwesterly line of Blocks 77, 58, 38, 19 and 10 in said addition, to the point of beginning, the same comprising and being all of blocks (and the lots included therein) numbered One (1) to Ten (10) inclusive, Nineteen (19) to Thirty-eight (38) inclusive, Fifty-eight (58) to Seventy-seven (77) inclusive and Ninety-six (96), Ninety-seven (97), Winety-eight (98) and One Hundred Sixteen (116); and

Elm Street from the Southwesterly line of Harrison Avenue to the East line of Harold Street;

Date Street from the Southwesterly line of Harrison Avenue to the Northeasterly line of 1st Street;

Cedar Street from the Southwesterly line of Harrison Avenue to the Northeasterly line of Jefferson Avenue;

North Main Street from the Southwesterly line of Harrison Avenue to the Northeasterly line of Jefferson Avenue;

Palm Street from the Southwesterly line of Harrison Avenue to the Northeasterly line of Jefferson Avenue; Laurel Street from the Southwesterly line of Harrison Avenue to the Northeasterly line of Jefferson Avenue;

Linden Street from the Southwesterly line of Harrison Avenue to the Northeasterly line of Jefferson Avenue;

Beach Street from the Southwesterly line of Harrison Avenue to the Northeasterly line of Jefferson Avenue;

Front Street from the Southwesterly line of Harrison Avenue to the Northeasterly line of Jefferson Avenue;

Harrison Avenue from the Southeasterly line of Walnut Street to the Southeasterly termination of said Harrison Avenue;

VanBuren Avenue from the Southeasterly line of Walnut Street to the Southeasterly termination of said VanBuren Avenue;

Jackson Avenue from the Southeasterly line of Walnut Street to the Southeasterly termination of said Jackson Avenue;

Monroe Avenue from the Southeasterly line of Walnut Street to the Southeasterly termination of said Monroe Avenue;

Madison Avenue from the Southeasterly line of Walnut Street to the Southeasterly termination of said Madison Avenue;

Jefferson Avenue from the East line of Harold Street to the Southeasterly termination of said Jefferson Avenue;

Adams Avenue from the East line of Harold Street to the Southeasterly termination of said Adams Avenue;

Washington Avenue from the East line of Harold Street to the Southeasterly termination of said Washington Avenue,
