An ordinance vacating Spanglers Addition to the City of Warrenton, Clatsop County, State of Oregon and the streets, alleys, lots, and blocks therein.

ORDINANCE NO 186

WHEREAS Frank W. Burns, a bechelor, filed a petition to the Common Council of the City of Warrenton on the the day of <u>May</u> 1917, for the vacation of the hereinafter bounded and described property known as Spanglers Addition to the City of Warrenton, said Spanglers Addition being a part of the City of Warrenton, Oregon.

WHEREAS said petitioner is the owner of said Spanglers Addition to the City of Warrenton consisting of Block one (1), two (2), three (3), four (4), and five (5), as shown by the blue print attached to said petition which is hereby referred to and made a part hereof to the same effect as though set out in full herein; the said Addition being situated in Section twenty-four (24) and twenty-five (25), Township eight (8), North Range ten (10), West Willamette Meridian, in Clatsop County, Oregon; said petition being duly filed with the Auditor and Police Judge of the City of Warrenton, THEREFORE;

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS; Section 1; That Spanglers Addition to the City of Warrenton consisting of Blocks one (1), two (2), three (3), four (4) and five (5), as shown by the blue print attached hereto and made a part hereof in the City of Warrenton, Oregon, be and the same is herewith vacated; all of said blocks being in the City of Warrenton in said Spanglers Addition situated in Sections twenty-four (240 and twenty-five (25), Township eight (8), North Range ten (10), West Willamette Meridian, in Clatsop County Oregon. Section 2;- That all of the Streets, Alley's, Lots and Blocks, in said Spanglers Addition be and the same is herewith vacated, that the streets hereby vacated are as follows, to-wit;-Fifth (5) street, from the east line of Fredrick street to the west line of Monroe street, fourth (4) street, from the east line of Fredrick street to the west line of Monroe street, third street from the east line of Fredrick street to the west line of Monroe street, second street (2) , from the east line of Fredrick street, to the west line of Monroe street, and first (1) street, from the east line of Fredrick street to the west line of Monroe street, and that said Blocks are numbered one(1) two (2) three (3); four (4) and five (5) in said Spanglers addition to the City of Warrenton, Clateop County, State of Oregon, and that all lots in each of said Blocks in said Spanglers addition and streets therein as aforesaid be and the same are hereby vacated.
