THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That there be and is herewith levied a tax of

assessible property as shown, listed, assessed and valued upon the Assessment Roll for Clatsop County, State of Oregon, for the year 1917, for the City of Warrenton, the total amount of money to be raised by taxation for the aforesaid purposes for the City of Warrenton, during the year 1918 being \$ 35,343 ⁰⁰/₁₀₀

Section 2. That the Auditor and Police Judge of the City of Warrenton be and he is hereby authorized to furnish to the County Clerk and also to the County Assessor of Clatsop County, Oregon, as required by law, a certificate showing the various tax levies made by this ordinance, and the said certificate shall be furnished to the said officials on or prior to the first day of December, 1917.
