ORDINANCE NO. 320 P Introduced by Commissioner Geo W. Welly.

AN ORDINANCE GRANTING TO THE GOVERNMENT OF THE UNITED STATES THE RIGHT TO USE JOINTLY WITH THE CITY OF WARRENTON A CERTAIN FORTY FOOT RIGHT OF WAY GRANTED TO THE CITY OF WARRENTON IN THAT CERTAIN DEED RECORDED IN VOLUME 160 ON PAGE 221 OF RECORDS OF DEEDS OF CLATSOP COUNTY, RUNNING FROM OREGON COAST HIGHWAY # 101 ACROSS, AND ALONG THE SOUTH BOUNDARY LINE OF, CERTAIN REAL PROPERTY FORMERLY OWNED BY WILLIAM CHADWICK AND MORE PARTICULARLY DESCRIBED IN THAT CERTAIN DEED RECORDED IN BOOK 55, PAGE 18 RECORDS OF DEEDS OF CLATSOP COUNTY:

WHEREAS, the City of Warrenton by deed duly recorded in Volume 160 on page 221 of Records of Deeds of Clatsop County, Oregon acquired certain real property for a reservoir site together with a forty foot right-of-way from OREGON COAST HIGHWAY # 101 over and across and along the south boundary line of certain real property formerly owned by William Chadwick and more particularly described in that certain deed recorded in Volume 55 on page 18 Records of Deeds of Clatsop County; and

WHEREAS, by virtue of Paragraph 3 of said right-of-way deed it is expressly provided that the City of Warrenton may grant unto the United States Government or any of its political divisions a joint right to said above mentioned right-of-way; and

WHEREAS, the United States Government acting by and through the Army Engineers of its War Department have made written application to the City of Warrenton for the joint permissive use of said above mentioned right-of-way;

NOW THEREFORE,

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

That the said application of the United States Government be and the same is hereby granted, and accordingly there is hereby granted unto the Government of the United States the right to use jointly with the City of Warrenton that certain forty foot rightof-way granted in said above mentioned deed recorded in Volume 160 Records of Deeds of Clatsop County on page 221, and running from Oregon Coast Highway # 101 over and across and along the south boundary line of certain real property formerly owned by William Chadwick and more particularly described in that certain deed recorded in Volume 55 Records of Deeds of Clatsop County on page 18 thereof, subject to all of the terms and conditions of said right-of-way when originally granted to the City of Warrenton.
