

ORDINANCE NO. 227

An Ordinance proposing an amendment to Section 3 of the existing municipal Charter of the City of Warrenton by adding thereto Section 3 "A" to provide a method for the election of Auditor and Police Judge and City Marshal, their terms of office, and fixing their salaries, the said proposed amendment to be submitted to the qualified voters of the City of Warrenton at a special election to be held on Friday, the 14<sup>th</sup> day of June, 1918, and declaring an emergency.

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS, AND BE IT ENACTED BY THE PEOPLE OF THE CITY OF WARRENTON:

Section 1. The Common Council of the City of Warrenton, deeming it expedient, hereby proposes the enactment of the following proposed amendment to Section 3 of the existing municipal Charter of the City of Warrenton, by adding Section 3 "A" thereto, to-wit:

BE IT ENACTED BY THE PEOPLE OF THE CITY OF WARRENTON: That Section 3 of the Charter of the City of Warrenton, it being an Act of the Legislative Assembly of the State of Oregon, which was approved February 11th, 1899, entitled "An Act to incorporate the City of Warrenton," as amended by an Act of said Legislative Assembly approved February 15th, 1901, and entitled "An Act to amend Sections 3, 5, 15, 48, 50, 57, 53, 58, 59, 68 and 34 of an Act entitled 'An Act to incorporate the City of Warrenton,'" be and said Section 3 is hereby amended by adding thereto Section 3 "A":

"Section 3 "A". The elective officers of said City of Warrenton shall include the Auditor and Police Judge, who shall be ex-officio recorder of said city, and City Marshal, who shall take office on the first Monday in January following their election, and hold office for the term of two years and until their successors are appointed and elected and shall qualify. The Common Council of the City of Warrenton shall fix the salaries to be paid the Auditor and Police Judge and City Marshal at the first meeting of the Common Council in January, after his election, by resolution or ordinance, and in case of vacancy by death or resignation, in either

of said offices, the Mayor shall nominate their successors, and the said nomination shall be confirmed by the Common Council of the City of Warrenton."

Section 2. All parts of the Charter of the City of Warrenton and all ordinances and parts of charter and ordinances of said city in conflict with the provisions of this charter amendment are hereby modified or repealed, as the case may require, in order that this amendment may be in full force and effect.

Section 3. This proposed amendment to the Charter of the City of Warrenton shall be submitted to the qualified voters of said city at a special election which has been called to be held on Friday, the 14<sup>th</sup> day of June, 1918, for the purpose of voting on proposed amendments to the Charter of the said City of Warrenton.

Section 4. The title of the proposed amendment, as hereinbefore set forth, to be voted upon at said special election shall be as follows: An Act to amend Section 3 of the existing municipal Charter of the City of Warrenton by adding thereto Section 3 "A" providing for the election of Auditor and Police Judge and City Marshal, and terms of their office, and providing for the fixing of their salaries.

Section 5. Inasmuch as the objects to be obtained by this ordinance will be of great benefit to the people of the City of Warrenton, and there exists and is an urgent necessity that this ordinance should take effect as soon as possible, so that the health, peace and safety of the <sup>people of the</sup> City of Warrenton may be preserved, an emergency is hereby declared to exist, and this section therefore, shall take effect when approved and adopted by the affirmative vote of two-thirds of all the members of the Common Council, and this ordinance shall then be in full force and effect, immediately after its approval by the Mayor of the City of Warrenton.
