AN ORDINANCE TO REGULATE MOTOR VEHICLE AND OTHER TRAFFIC BY ESTABLISHING CERTAIN STOP SIGNS NEAR INTERURBAN RAILWAY GRADE CROSSINGS ON GARFIELD AVENUE AND SCHOOL ROAD IN THE CITY OF WARRENTON; PROHIBIT CROSSING WITHOUT STOPPING AT SAID POINTS AND TO PROVIDE FOR OFFICIAL TRAFFIC SIGNS AND TO PROVIDE A PENALTY FOR VIOLATION THEREOF

WHEREAS, Garfield Avenue has an interurban railway grade crossing intersecting it and,

WHEREAS, School Road has an interurban railway grade crossing intersecting it and,

WHEREAS, there are no city or state stop signs located at either side of said intersections and,

WHEREAS, it is for the public health and safety of the residents of the City of Warrenton that signs be erected on both sides of said interurban railway grade crossing where it intersects Garfield Avenue and School Road,

NOW THEREFORE THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That stop signs be placed on the northerly and southerly sides of the intersection of Garfield Avenue with the interurban railway grade crossing in the City of Warrenton, Oregon and that motor vehicles and other vehicles are prohibited from crossing said intersection without making a complete stop before proceeding over said intersection.

Section 2. That stop signs be placed on the westerly and easterly sides of the intersection of School Road with the interurban railway grade crossing in the City of Warrenton, Oregon and that motor vehicles and other vehicles are prohibited from crossing said intersection without making a complete stop before proceeding over said intersection.

Section 3. Ordinance No. 207A be and is hereby affirmed and this ordinance be and is hereby made an additional ordinance regulating vehicular traffic.

Section 4. That the placing of official traffic signs consisting of railroad stop signs at the intersections above described be and is hereby authorized.

Section 5. Every person convicted of violating any of the provisions of this ordinance shall be punished by a fine of not more than \$150.00 or by imprisonment in the City Jail of not more than 50 days. For a second or subsequent conviction within one year thereafter, such person shall be punished by a fine of not more than \$300.00 or by imprisonment in the City Jail of not more than 150 days or by both such fine and imprisonment.
