## THE CITY OF WARRINTON DOES OR DAIN AS FOLLOWS:

Section 1. That Albany Avenue from the intersection of East Water Street at the northeast corner thereof with said Albany avenue, running thence easterly along the north side of said Albany avenue in East Warrenton to the Hill slough bridge. Thence from the east end of said Hill slough bridge, running easterly along the south side of said Albany Avenue to the plank readway running north and south on Hayes street in the First Extension to East Warrenton; be end the same is hereby ordered improved by laying and constructing a six foot sidewalk along one side thereof as above described, with  $2^{''}_{--}8^{''}_{--}x_{--}^{''}$  placks laid upon  $3-3^{''}_{--}x_{--}^{''}$  stringers.

Said improvement shall be made and constructed according to plans and specifications as made and filed for constructing the same, and the resolution adopted on the 5th day of May, 1919, declaring the intention to make said i provement, and in accordance with notice of the intention and determination of the Common Council to construct said improvement, proof of publication of which is on file with the Auditor and Police Judge of the City of Warrenton, and said resolution, proof of publication and plans and specifications and estimates of the costs and expenses of making said improvement are hereby referred to, approved, confirmed, adopted and made a part hereof as though set out in full herein.

Section 2. The Committee on Streets and Public Improvements of the Common Council of the City of Warrenton be and the same is hereby authorized and directed to advertise for bids for the construction of said improvement and report the same to the Common Council, and upon the acceptance of the lowest and best responsible bid, said Council to enter into contract with such bidder for the construction of said improvement. The contract shall provide that said improvement shell be con-

structed and completed to the satisfaction of the Committee on Streets and public Improvements and other officers of the City of Warrenton whose duties it may be to accept street improvement work, and that the work shall be completed on or before the \_\_\_\_\_ day of \_\_\_\_\_\_ 1919. ORDINANCE NO 246

AN ORDIMANCE providing for the time and manner of improving Albany Avenue from the intersection of East Water Street at the northeast corner thereof with said Albany Avenue, running thence easterly along the north side of said Albany Avenue in East Warrenton to the Hill slough bridge. Thence from the east end of said Hill slough bridge, running easterly along the south side of said Albany Avenue to the plank readway running north and south on Hayes street in the First Extension to East Warrenton, in the City of Warrenton, Cletcop County, Oregon, adopting, approving and confirming the resolution heretofore adopted, declaring the intention to improve said street, by placing a sidewalk thereon, and adopting, confirming and approving plans and specifications prepared and filed for making the said improvement, and declaring an emergency.

WHEREAS, the Common Council of the City of Warrenton, on the 5th day of May, 1919, adopted a resolution declaring its intention to improve Albany Avenue from the intersection of East water Street at the northeast corner thereof with said Albany Avenue, running thence easterly along the north side of said Albany Avenue in East Warrenton to the Hill slough bridge. Thence from the east end of said Hill slough bridge, running easterly along the south side of said Albany Avenue to the plank roadway running north and south on Hayes street in the First Extension to East Warrenton, all in the City of Warrenton, by laying and constructing a six foot sidewalk along one side thereof as above described.

WHEREAS, due and legal notice of the intention and deterministion of the Common Council to make sold improvement already mentioned, has been given, as appears from the proof of publication filed with the Auditor and Police Judge, and plans and specifications has been made and filed with the said Auditor and Police Judge for the construction of sold improvement, and estimates of the costs and expenses thereof. Caid resolution and proof of publication and said plans and specifications and estimates of the costs and expenses of making said improvement are hereby referred to and made a part hereof as though set out in hace verba herein, and

WHEREAS, no remonstrance has been filed against the said improvement, therefore,

and for each day's delay in the completion of the said improvement as above provided, unless the time shall be extended by ordinance, the contractor shall forfeit and pay to the Dity of Warrenton as stipulated damages, the sum of  $\frac{200}{200}$  per day for each day's delay in the completion of said work thereafter.

The contractor shall have full charge of the work and shall be responsible for all accidents and injuries occurring on said improvement while in the course of construction and during the progress of the work and until said improvement shall be accepted by the Common Council of the City of Warrenton, and shall save the City of Warrenton harmless on account of any injury to any person or persons happening upon the said improvement while in the course of construction and until said improvement is completed and accepted by the Common Council of said City, and shall save the City harmless from all damages to private property caused by or on account of the construction of said improvement is completed and accepted by the Common fail amages to private

That said contract entered into by and between the City of Warrenton and the contractor for the improvement of the street as aforesaid shall provide that the contractor shall promptly, as due, make payments to all persons supplying the said contractor with labor, services or material for the prosecution or completion of said work provided for in said contract, and that said contractor shall not permit any liens or claims to be filed or prosecuted against the City of Warrenton for or on account of any labor or material furnished him in the prosecution or fulfillment of the terms of said contract with the said City of Warrenton and as provided for by said resolution and said plans and specifications hereinbefore referred to and made a part of this ordinance.

The said contract shall provide that during the performance of said contract, no person or persons shall be permitted or required to labor more than eight hours in any one cale dar day or more than fortyeight hours in any one calendar week, except in cases of necessity, emergency or where public policy should be required it, and in such event, the person or persons so employed for excessive hours shall receive double pay for the over-time so employed, and no necessity, emergency or public policy shall be presumed to exist when other labor of like skill and efficiency which has not been employed full time is available, and no person shall be employed by the said contractor who is not a citizen of the United States of America or who has not declared his intention to become such.

That payments shall be made in warrants of the City of Warrenton upon the special fund constituted to defray the costs and expenses of the improvement, and that payments shall be made within ninety. (90) days from the time the improvement shall be accepted.

The contractor shall be required to give either a surety company bond or a personal bond, and in the event of a personal bond, with two or more sufficient sureties in the penal sum of seventy-five per cent of the contract price, conditioned for the faithful performance of the contract.

Section 3. Inesmuch as the objects to be obtained by this ordinance will be of great benefit to the people of the City of Warrenton and there exists and is an urgent necessity that this ordinance should take effect as soon as possible, so that the health, peace and safety of the people of the City of Warrenton may be preserved, an emergency is hereby declared to exist, and this section therefore, shall take effect when approved by the affirmative vote of two-thirds of all the members of the Common Council, and this ordinance shall then be in full force and operative immediately after its approval by the Mayor of the City of Warrenton.
