

AN ORDINANCE CONFIRMING SPECIAL ASSESSMENT ROLL NO. _____

WHEREAS, Special Assessment Roll No. _____ has been made by the Board of Assessors and reported to the Council and after due and legal notice equalized and corrected by the Board of Equalization, duly reported to the Council with the recommendation that the same be confirmed, and it appearing that the same was regularly made as provided by law, and that all property is justly assessed, therefore,

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That Special Assessment Roll No. _____, made for defraying the costs and expenses of improving part of Albany Avenue in East Warrenton and in the First Extension of East Warrenton; also part of Second Street from part of the distance between Hemlock and Main Streets, also part of Third Street for part of the distance between Hemlock and Main Streets; both streets being in Warrenton Addition to Astoria, in Warrenton; also part of Third Street from Cedar Street to Date Street; also part of Date Street from Third Street to a point opposite Lot 11 in Block 4, both streets being in Warren's First Extension of Warrenton, by laying and constructing a six foot sidewalk along one side of said streets along such portions of said streets as are hereinbefore named, and that said costs and expenses amount to \$ 2090 85, upon the following described property, to wit:
