

AN ORDINANCE providing for the laying and installing of a water main or extension along Wheeler St. & Corvallis Avenue, connecting on to the present water system at the intersection of Albany Avenue and Wheeler Street extending to Lot 10, Block 11, Corvallis Ave, and directing the said improvement to be paid for by assessments upon the property hereinafter described, in proportion to the benefits derived therefrom, the property to be assessed being:

 Lots 2, 3, 4, 5, 6, and 7 in Block 21,
 Lots 9, 10, 11, 12, 13, 14 and 15 in Block 27,
 All in First Extension of East Warrenton in
 the City of Warrenton, Oregon; and also

Lots 1, 2, 3 and 4 in Block 17,
 Lots 4, 5, 6, and 7 in Block 10,
 Lots 9 and 10 in Block 11,
 Lots 7 and 8 in Block 16,
 In Warrenton Park Addition to the City of
 Warrenton, in the City of Warrenton, Oregon.

That WHEREAS, the water Commission of the City of Warrenton has been petitioned for the laying of a water extension line connecting on to the present water system at Wheeler Street and running along Corvallis Avenue & Wheeler Street to Lot 10 Block 11, Corvallis and Avenue in Warrenton Park in Warrenton Oregon, and

WHEREAS, certain of the property owners have filed a remonstrance to the making of said improvement, and

WHEREAS, under the Charter of the City of Warrenton, the provisions of which direct the water Commission in such cases to bring the matter before the Common Council of the City of Warrenton, and the said Water Commission has presented the same to the Common Council of the City of Warrenton.

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That the Water Commission of the City of Warrenton be and they are hereby directed to install a water extension pipe connecting on to the present water main at Wheeler Street, running thence along Corvallis Avenue & Wheeler Street to Lot 10 in Block 11 Corvallis Avenue in Warrenton Park in Warrenton Oregon

the said water extension to be 4 and 2 inches in diameter and laid underneath the ground, in accordance with plans and specifications now on file with the Water Commission of the City of Warrenton, and that the expense of installing said water extension and the making of said improvement shall be paid by assessment upon the property benefitted by said improvement, and that the property so benefitted and situated in the district to be improved shall be:

Lots 2, 3, 4, 5, 6 and 7 in Block 21,
Lots 9, 10, 11, 12, 13, 14, and 15 in Block 27,
In First Extension of East Warrenton in the City
of Warrenton, Oregon; and also

Lots 1, 2, 3 and 4 in Block 17,
Lots 4, 5, 6 and 7 in Block 10,
Lots 9 and 10 in Block 11,
Lots 7 and 8 in Block 16,
In Warrenton Park Addition to the City of Warrenton,
Clatsop County, State of Oregon;

and that each of said lots shall be assessed in proportion to the benefits derived by the making of said improvement in accordance with the provisions of the Charter of the City of Warrenton, giving unto the Water Commission of the City of Warrenton power to make improvements by the laying of water mains and extensions.
