

AN ORDINANCE ACCEPTING THE IMPROVEMENT OF A PORTION OF SALEM AVENUE IN WARRENTON, AND DIRECTING THAT ASSESSMENTS BE MADE UPON THE PROPERTY THEREBY BENEFITED TO DEFRAY THE EXPENSE OF SUCH IMPROVEMENT, AND DECLARING AN EMERGENCY.

WHEREAS, The Common Council having heretofore by Resolution and Ordinance authorized and directed the improvement of a portion of Salem Avenue, described as follows:

Beginning at a point twelve(12) feet North of the center line of said Salem Avenue where same intersects the West boundary line of the planking constituting the covering or driveway now laid along Wheeler Street in said City. Thence Westerly along said Salem Avenue twelve(12)feet north of and parallel with the center line thereof a distance of ninety(90)feet, thence continuing along said Salem Avenue at a distance of four(4) feet from and parallel with the center line thereof a further distance of one hundred and thirty six(136)feet. Thence southerly at right angles eight(8)feet: thence Easterly parallel with the center line of Salem Avenue and four (4) feet therefrom, for a distance of one hundred and thirty six(136)feet: thence Southerly eight(8)feet at right angles: thence Easterly twelve(12) feet from and parallel with said center line of Salem Avenue for a distance of ninety (90)feet to a junction with the aforesaid westerly boundary line of the planking constituting the covering or driveway on said Wheeler Street, by laying and constructing thereon, standard planking on the usual stringers in pursuance of a petition therefor which had theretofore been duly filed with the Council praying that said improvement be so made:and

WHEREAS, It is necessary that assessments be levied against the real property benefited by said improvement for the purpose of raising a special fund with which to defray the expense of said improvement, as aforesaid; Now, therefore,

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That the Board of Assessors of the City of Warrenton, consisting of V.H.Coffey John Syvers W.L.Williams be, and it hereby is, authorized and directed to assess the hereinafter described property, in accordance with the benefits accruing the same from said improvement, in the sum of \$_____, the property to be so assessed and included in a special assessment district is particularly described as follows, to-wit:
Lots numbered 1--2--3--4 in Block 28 and Lots numbered 17--18--19--20--in Block 29 all in the First Extension of East Warrenton in the City of Warrenton Oregon.

Section 2. That said Board of Assessors in making said assessment as aforesaid shall make out a list of said lots, land and premises by proper description, giving the valuation of each lot or parcel of land thereof, with the names of the reputed owners, and shall levy thereon, against such owners and lots and parcels of land, the amount to be assessed in the manner provided in this Ordinance and the Charter of the City of Warrenton, and when said assessment is completed it shall report the same to the Council at its next regular meeting, if practible, and if not, then as soon thereafter as may be possible.

Section 3. That the enactment of this ordinance at this time, and the taking effect of the same forthwith, is necessary for the immediate preservation of the public peace, health and safety of the inhabitants of the City of Warrenton, and, therefore, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect upon its passage by the Council and approval by the Mayor of the City of Warrenton.

Section 1. That the portions of Salem Avenue described as follows:
Beginning at a point twelve (12) feet North of the center line of said
Salem Avenue where same intersects the West boundary line of the planking
constituting the covering or driveway now laid along Wheeler Street in said
City. Thence Westerly along said Salem Avenue twelve (12) feet North of and
parallel with the center line thereof a distance of ninety(90)feet, thence
continuing along said Salem Avenue at a distance of four(4)feet from and
parallel with the center line thereof a further distance of one hundred
and thirty six(136)feet. Thence Southerly at right angleseight(8)feet: thence
Easterly parallel with the center line of Salem Avenue and four(4)feet there
from, for a distance of one hundred and thirty six (136)feet: thence Souther
ly eight feet at right angles: thence Easterly twelve(12) feet from and par
allel with said center line of Salem Avenue for a distance of ninety(90)feet
to a junction with the aforesaid Westerly boundary line of the planking
constituting the covering or driveway now laid along Wheeler Street, be, and
the same is hereby directed to be improved by laying and constructing stand
ard planking, on the usual stringers, along the center thereof: such planking
or roadway being more particularly described as follows:- On the twenty four
foot planking or roadway, decking to be of sound red fir, 5"x12"x12' laid on
12--3"x6" stringers well nailed with 60D nails. On the eight foot planking o
r roadway: decking to be of sound red fir lumber, 3"x12"x8' laid on 4--3"x
#6" stringers well nailed together with 60D nails.
