## ORDINANCE NO. 305.

AN ORDINANCE, AUTHORIZING CERTAIN PARTS OF WATER AND SECOND STREETS TO BE IMPROVED FOR THE DISTANCE, AND IN THE MANNER, PARTICULARLY SET FORTH IN THE BODY OF THE ORDINANCE, AND DECLARING AN EMERGENCY.

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

WHEREAS, The Common Council, by a resolution duly adopted on September 1, 1921, declared its intention to improve and construct certain parts of Water and Second streets, hereinafter particularly described; and

WHEREAS, Notice of the Council's intention to so make said improvement has been duly published in the Warrenton News, a weekly newspaper, printed and published in said City of Warrenton, in pursuance of §50 of the last amended Charter of the City of Warrenton; and

WHEREAS, The time for filing remonstrance against said proposed improvement having elapsed, and no remonstrance whatsoever having been made or filed against said proposed improvement; and

WHEREAS, The Council in said resolution directed and caused estimates of the cost of said proposed improvement, and specifications for the same, to be made, and deposited with the Auditor and Police Judge of said City, all of which has heretofore been duly done accordingly; Now, therefore,

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That the portions of Water Street and of Second Street, in Warren's First Extension to Warrenton, respectively described as follows:

Beginning at the Mortherly boundary of the grade crossing of the S. P. & S. R'y Co., on said Water Street; thence along said Water Street, in a Northerly direction, to the South line of the new public dock, now under construction, near the foot of said Water Street; and, also, said Second Street, from the West line of said Water Street, running thence in a Westerly direction, for a distance of fifty (50) feet, in-

thence in a Westerly direction, for a distance of fifty (50) feet, including the intersections of such streets.—
be, and they hereby are, directed to be improved by grading and filling said Water Street, and macadamizing the same, 18 feet in width, along the center thereof, along the course and distance of such street above given and described; and, also, by grading and planking an approach to said dock, on the South side thereof, on said Water Street, such approach to be 40 feet long and 18 feet wide; and, also, by grading and filling said Second Street, along the course and distance of such street above given and described, and by macadamizing the portion thereof 25.3 feet wide, extending from the South line of said dock, in Block 117 of said Addition, to the center of said Second Street; and, also, by macadamizing the intersection of said Second and Water streets, all to be done in accordance with the plans, specifications, and drawings on file in the office of the Auditor and Police Judge, and in accordance with said resolution.

Section 2. That the Auditor and Police Judge be, and he hereby is, authorized and directed to call for bids for the making of said proposed improvement in the manner aforesaid, by publishing a call for such bids in two successive weekly issues of the Warrenton News aforesaid.

Section 3. That upon said bids being received and opened at the time and place stated in said call, by the Street and Public Highways Committee, such Committee is hereby authorized and directed to enter into a contract, in behalf of said City, for the making of said improvement, with the lowest responsible bidder therefor, if in such Committee's discretion any one of said bids should be accepted, and if all of said

bids received in pursuance of said call should, in the opinion of said Committee, be rejected, or if no bids be received, then the Auditor and Police Judge is hereby authorized and directed to publish another call for bids, in the manner, and for the time, herein required for the first call for said bids, the same authority being given to said Committee to open the second bids and enter into a contract for said proposed improvement, in the manner hereinbefore stated.

Section 4. That the enactment of this ordinance at this time, and the taking effect of same forthwith, is necessary for the immediate preservation of the public peace, health and safety of the inhabitants of the City of Warrenton, and, therefore, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect upon its passage by the Council and approval by the Mayor of the City of Warrenton.
