

AN ORDINANCE, AUTHORIZING THE IMPROVEMENT OF A PORTION OF MARKET STREET, BY PAVING THE SAME, AFTER FILLING, GRADING AND LEVELING SAME TO GRADE, AND DECLARING AN EMERGENCY.

WHEREAS, The Common Council, by a resolution duly adopted on the First day of December, 1921, declared its intention to improve the following described portion of Market Street, in the City of Warrenton, Clatsop County, Oregon, to-wit: Beginning at a point on said Market Street, which is nine (9) feet West of the point where such Street intersects the center line of Water Street; thence running Westerly along said Market Street to the point where the same strikes the East boundary line of the pavement now on Main Street in said City;-- by paving the same, along the center thereof, for the width of twenty-five (25) feet with a pavement of the following specifications:  
*Bituminous pavement on concrete, Bituminous, or Crushed rock base*

Or with a pavement of the following specifications:

*One Course Concrete Pavement*

and by filling, grading, and leveling the same to the street grade; and AND WHEREAS, Notice of the Council's intention to make said improvement, as aforesaid, has been duly published in The Warrenton News, for the time and in the manner and substance required by Section 50 of the last amended Charter of the City of Warrenton; and

WHEREAS, the time for filing remonstrances against said improvement has elapsed, and that only remonstrance against the same was filed by the Spokane, Portland & Seattle R'y Co., a corporation, which owns less than one-half of the property in the district wherein the special assessment is to be levied for the purpose of raising a fund with which to pay for said proposed improvement of Market Street; and

WHEREAS, the Council, in said resolution directed and caused estimates of the cost of said proposed improvement, and specifications for the same, to be made and deposited in the office of the Auditor and Police Judge of said City, all of which has heretofore accordingly been done; Now, therefore,

THE CITY OF WARRENTON DOES ORDAIN as follows:--

Section 1. That the portion of Market Street, in Warrenton, Oregon, described as follows, to-wit:

Beginning at a point on said Market Street, which is nine (9) feet West of the point where such Street intersects the center line of Water Street; thence running Westerly along said Market Street to the point where the same strikes the East boundary line of the pavement now on Main Street in said City;--

by paving the same, along the center thereof, for the width of twenty-five (25) feet, with a pavement of the following specifications:

*Bituminous Pavement on Concrete, Bituminous or crushed rock base*

Or with a pavement of the following specifications:

*One Course Concrete Pavement*

and by filling, grading, and leveling the same to the street grade, all in accordance with said specifications, filed as aforesaid, and said resolution, declaring the Council's intention to make such improvement.

Section 2. That the Auditor and Police Judge be, and he hereby is, authorized and directed to call for bids for the making of said proposed improvement, in the manner aforesaid, by publishing the same in two successive issues of the weekly Warrenton News, a newspaper published in, and of general circulation in said City of Warrenton.

Section 3. That upon said bids being received and opened by the Streets and Public Ways Committee, at the time and place stated in said call for bids, such Committee is hereby authorized and directed to enter into a contract, with the lowest responsible bidder therefor, in behalf of said City, for the making of said proposed improvement, if in such Committee's discretion, any of said bids should be accepted, and if all of the bids received in pursuance of said call should, in the opinion of

said Committee, be rejected, or if no bids be received, then, the Auditor and Police Judge is hereby authorized and directed to publish another call for bids, in the manner and for the time herein required for the first call for said bids, the same authority being hereby given the said Committee to open the second bids and enter into a contract for the making of said proposed improvement, in the manner hereinbefore stated.

Section 4. That the enactment of this ordinance at this time, and the taking effect of same forthwith, is necessary for the immediate preservation of the public peace, health and safety of the inhabitants of said City of Warrenton, for the reasons that large quantities of water and mud have accumulated upon said Market Street, at the point where said proposed improvement is to be made, thereby endangering the health and safety of the inhabitants of said City, and, therefore, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect upon its passage by the Common Council and approval by the Mayor of the City of Warrenton.


Section 5. That the said remonstrance of the Spokane, Portland and Seattle Railway Company, a corporation, which owns less than one-half of the property situated in the improvement district wherein the special assessment is to be levied to secure funds for the purpose of defraying the expense of said improvement, be, and the same hereby is, overruled and disallowed, as the Council finds that it will be to the best interests of a majority of the inhabitants and property owners directly interested in said proposed improvement that the same be made at this time, and in the manner aforesaid.
