ORDINANCE NO. 329.

AN ORDINANCE, AUTHORIZING THE IMPROVEMENT OF A PORTION OF CEDAR STREET, BY LAYING A SIDEWALK ALONG ONE SIDE THEREOF, AND DECLAR-ING AN EMERGENCY.

THE CITY OF WARRENTON DOES ORDAIN as follows:

Section 1. That the portion of Cedar Street in the City of Warrenton, Pregon, described as follows: Beginning at the north boundary line of The Street; thence running to the South boundary line of Sthe Street; said sidewalk to be laid along the be improved in the following described manner: By laying a wood sidewalk five (5) feet wide, one (1) inch thick decking to be laid oth 7"x 4" stringers; said sidewalk to be constructed of no. 1 fir lumber.

That said improvement shall be made in accordance with the plans and specifications therefor, now on file in the office of the Auditor and Police Judge of said City.

Section 2. That the Auditor and Police Judge be, and he hereby is, authorized and directed to call for bids for the making of said proposed improvement in the manner aforesaid, by publishing the same in two successive weekly issues of The Warrenton News, a weekly newspaper published in, and of general circulation in, said City.

Section 3. That upon said bids being received and opened, either by the Common Council, or by the Committee on Streets and Public Ways, at the time and place stated in said call for bids, such Committee, or Council, or other person or persons, whom the Council may authorize, is hereby empowered and directed to enter into a contract for the making of said proposed improvement, if, in the discretion of the Council, or said Committee, thus considering said bids, any of said bids should be accepted, but if all of the bids received in pursuance of said call should, in the judgment of the Council, or said Committee, be rejected, or if no bids be received, then, the Auditor and Police Judge is hereby authorized and directed to publish another call for bids, in the manner, and for the time, herein required for the first call for bids, the same authority being hereby given the Council, or said Committee, to open the second bids and enter into a contract for the making of said proposed improvement, in the manner hereinbefore stated, and other bids may be called for in like manner, so long as the Council, or said Committee, to open the rejecting the bids, may by its motion so order.

Section 4. That, since said proposed improvement can be more advantageously made during the summer and fall months, before the winter rains set in, and since such improvement is absolutely necessary for use by the inhabitants of said proposed improvement district, in order to protect the public health, peace, and safety of said City, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect upon its passage by the Council and approved by the Mayor of the City of Warrenton, Oregon.

Section 5. That the time allowed by the charter and ordinances of said City of Warrenton, wherein interested persons may remonstrate against said proposed improvement, has elapsed, and no person or persons whomsoever has remonstrated, in any manner whatsoever, against said proposed improvement.

Passed by the Council and approved by the Mayor on this 15th day of September, A.D.1922.
