ORDINANCE NO. <u>333</u> a Introduced by Commissioner Quincy Robinson

AN ORDINANCE PROVIDING FOR A SPECIAL ELECTION TO BE HELD IN THE CITY OF WARRENTON, COUNTY OF CLATSOP, STATE OF OREGON ON TUESDAY, NOVEMBER 2, 1954 FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE CITY OF WARRENTON A CHARTER AMENDMENT TO AMEND SECTION 10 OF CHAPTER 3 OF SAID CHARTER BY ADDING A PROVISION FOR DECLARATION OF CANDIDACY AND PROVIDING A PLACE FOR FILING, FILING FEE AND TIME OF FILING FOR BOTH CERTIFICATES OF NOMINATION AND DECLARATION OF CANDIDACY FOR THEIR APPROVAL OR REJECTION, AND PROVIDING THE TIME, MANNER AND METHOD OF HOLDING SUCH SPECIAL ELECTION.

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That there be and there is hereby ordered and ordained to be held in the City of Warrenton, Clatsop County, State of Oregon, a special election of the legal voters thereof on Tuesday, the 2nd day of November, 1954 at which election there shall be submitted to the legal voters of the City of Warrenton for their approval or rejection the following ^Charter Amendment, to-wit:

CHARTER AMENDMENT SUBMITTED TO THE VOTERS BY THE CITY COMMISSION

AN ACT

TO AMEND THE CHARTER OF THE CITY OF WARRENTON, OREGON BY AMENDING SECTION 10 OF CHAPTER 3 OF SAID CHARTER BY ADDING A PROVISION FOR DECLARATION OF CANDIDACY AND PROVIDING PLACE FOR FILING, FILING FEE AND TIME OF FILING FOR BOTH CERTIFICATES OF NOMINATION AND DECLARATION OF CANDIDACY.

BE IT ENACTED BY THE PEOPLE OF THE CITY OF WARRENTON, CLATSOP COUNTY, OREGON That the Charter of the City of Warrenton, Oregon be amended by amending Section 10 of Chapter 3 and the amendment to Section 10 of Chapter 3 to read as follows:

NOMINATING PROCEDURE

Section 10 of Chapter 3. All general municipal elections shall be held in accordance with the general election laws then in force in the State of Oregon, or any amendments thereof, except as in this Charter otherwise provided and provided that certificates of nomination made by individual electors shall be signed by not less than 10% of the total number of electors voting at the last preceding city election. As an alternative method, any qualified registered elector may become a candidate by making and filing his or her declaration of candidacy in a form substantially the same as provided by the State of Oregon election laws, with the Auditor and Police Judge of the City of Warrenton, not less than 30 days before the day fixed by law for said election, provided said candidate accompanies his said declaration with a filing fee, the sum of which shall be set by vote of the City Commission. Certificates of nominations shall also be filed with said Auditor and Police Judge not less than 30 days before the day fixed by law for said election.

Section 2. That the following ballot title is hereby adopted for said amendment:

CHARTER AMENDMENT CHANGING NOMINATING PROCEDURE

Shall Charter of City of Warrenton, Oregon be amended by amending Section 10 of Chapter 3 of said Charter, by adding a provision for declaration of 51 candidacy and providing for place of filing, filing fee and time of filing for both certificates of nomination and declaration of candidacy?

Section 3. That the Auditor and Police Judge of the City of Warrenton shall, at least 20 days prior to the time when said special election is to be held, cause notice thereof to be given to the legal voters (electors) of the City of Warrenton, by posting not less than three notices in each precinct of the City of Warrenton announcing the passage of this Ordinance, and stating the time and place when said special election shall be held, the names of the Judges and Clerks of said special election, polling places designated therefor and setting forth the Charter Amendment to be voted upon at said special election, which said notices shall be posted in conspicuous places in each precinct of the City of Warrenton and setting forth that said special election is to be

That the polling place of election precinct No. 1 is the Fire Station of the City of Warrenton located on Fourth Street in the City of Warrenton, Oregon.

Section 7. That the boundaries of election precinct No. 2 of the City of Warrenton shall be as follows: <u>all the incorporated</u> <u>limits of the City of Warrenton lying East of Main Street except</u> <u>Block 9, which is included in Precinct 2, also.</u>

That the polling place of election precinct No. 2 is the City Hall of the City of Warrenton located on Main Street in the City of Warrenton, Oregon.

Page Three

Section 8. That the polls for said Special Election shall be open for said Special Election at the hour of 8 o'clock A.M. and remain open until the hour of 8 o'clock P.M. on the day of such Special Election.

Section 9. That the Auditor and Police Judge of the City of Warrenton shall, at least twenty days prior to the time when said Special Election is to be held, cause notice thereof to be given to the legal voters (electors) of the City of Warrenton by posting three notices in each precinct in the City of Warrenton announcing the passage of this Ordinance and containing the ballot title of the proposed amendment and which Notice shall be posted in conspicuous places in each precinct.
