AN ORDINANCE PROVIDING FOR A SPECIAL ELÉCTION TO BE HELD IN THE CITY OF WARRENTON, COUNTY OF CLATSOP, STATE OF OREGON, TUESDAY, NOVEMBER 2, 1954 FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE CITY OF WARRENTON THE FOLLOWING MEASURE BEING AN ORDINANCE PROVIDING FOR THE FLUORIDE SUPPLEMENTATION OF PUBLIC WATER SUPPLIES FOR THE CITY OF WARRENTON, FOR THEIR APPROVAL OR REJECTION, AND PROVIDING THE TIME, MANNER AND METHOD OF HOLDING SUCH SPECIAL ELECTION.

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That there be and there is hereby ordered and ordained to be held in the City of Warrenton, County of Clatsop, State of Oregon a special election of the legal voters thereof on Tuesday, the 2nd day of November, 1954 at which election there shall be submitted to the legal voters of the City of Warrenton for their approval or rejection the following Ordinance, to-wit:

AN ORDINANCE PROVIDING FOR THE INTRODUCTION OF FLUCRIDES INTO THE MUNICIPAL WATER SUPPLY OF THE CITY OF WARRENTON.

WHEREAS, competent medical research has determined that the Warrenton water supply is lacking in fluorides necessary for good dental health, and

WHEREAS, 1000 communities in the United States, including nine Oregon cities are currently deriving benefits from the addition of fluorides to their water supplies, and

WHEREAS, the Clatsop County Dental Society; Clatsop County Health Department; Clatsop County Medical Society; Oregon State Medical Society; Oregon State Board of Health; American Dental Association; American Medical Association; National Congress of Parents and Teachers; American Waterworks Association; and many local civic and service organizations have endorsed fluoridation for communities in which the water supply is deficient in fluoride content, and

WHEREAS, the addition of trace amounts of fluorides has been conclusively shown to be non-injurious to the health of any age group; now therefore

BE IT ENACTED BY THE PEOPLE OF THE CITY OF WARRENTON, OREGON:

Section 1. The City Commissioners and the City Manager are hereby authorized and directed to provide the means for and proceed with the addition of appropriate amount of fluorides conducive to better health to the municipal water supply of the city of Warrenton, in accordance with the regulations of the Oregon State Board of Health for the fluoride supplementation of public water supplies.

Section 2. Revenue to provide the means of financing this project shall be obtained by charging domestic water accounts such increases as are found necessary.

Section 2. That the following ballot title is hereby adopted

for said measure:

Section 3. That the Auditor and Police Judge of the City of Warrenton shall, at least 20 days prior to the time when said special election is to be held, cause notice thereof to be given to the legal voters (**ëlëctors**) of the City of Warrenton, by posting not less than three notices in each precinct of the City of Warrenton announcing the passage of this Ordinance, and stating the time and place when said special election shall be held, the names of the Judges and Clerks of said special election, polling places designated therefor and setting forth the Measure, which is an Ordinance, to be voted upon at said special election, which said notices shall be posted in conspicuous places in each precinct of the City of Warrenton and setting forth that said special election is to be held at the time and in the polling places herein designated.

Section 4. That Elsie Smith, Katherine Ford and Ellen W. Sylling be and they are hereby appointed Judges and Helen Lenhard and Ann Tetlow be and they are hereby appointed Clerks of the special election to be held in the City of Warrenton on the 2nd day of November, 1954 and they are hereby ordered and directed to be present at the polling place of election precinct No. 1 which is hereby ordered located on Fourth Street, to the casting of ballots of said Special Election as by law provided.

Section 5. That the boundaries of election precinct No. 1, City of Warrenton, shall be as follows: All lands in the City limit lying West of State Secondary Highway 104, commonly known as Main Street, except Block 9, <u>Warrenton Addition</u> which is located in Page Two, Ordinance.

Precinct 2.

Section 6. That Hazel Moore, Bernice Mansfield and Iva B. Christensen be and they are hereby appointed Judges and Frances G. Wilson and Lulu Fenton be and they are hereby appointed Clerks of the special election to be held in the City of Warrenton on the 2nd day of November, 1954 and they are hereby ordered and directed to be present at the polling place of election precinct No. 2 which is hereby declared to be the City Hall of the City of located on Main Street, Warrenton/and attend to the casting of ballots in said special election as by law provided.

Section 7. That the boundaries of election precinct No. 2 of the City of Warrenton shall be as follows: All the incorporated limits of the City of Warrenton lying East of Main Street, plus Block 9, Warrenton Addition which is also included in Precinct 2.

Section 8. That the polls for said Special Election shall be open for said Special Election at the hour of 8 o'clock A.M. and remain open until the hour of 8 o'clock P.M. on the day of such Special Election.

Section 9. That the Auditor and Police Judge of the City of Warrenton shall, at least twenty days prior to the time when said Special Election is to be held, cause notice thereof to be given to the legal voters (electors) of the City of Warrenton by posting three notices in each precinct in the City of Warrenton announcing the passage of this Ordinance and containing the ballot title of the proposed Measure and which Notice shall be posted in conspicuous places in each precinct.
