ORDINANCE NO. 3467

AN ORDINANCE FOR THE APPOINTMENT OF JUDGES AND CLERKS AND POSTING OF NOTICES THEREFOR FOR THE GENERAL ELECTION TO BE HELD ON THE 6TH DAY OF NOVEMBER, A.D. 1956 FOR THE ELECTION OF THREE COMMISSIONERS AND AN AUDITOR AND POLICE JUDGE OF THE CITY OF WARRENTON, COUNTY OF CLATSOP, OREGON AND AT SAID GENERAL ELECTION THERE SHALL BE SUBMITTED TO THE LEGAL VOTERS OF THE CITY OF WARRENTON AN ORDINANCE PROHIBITING FLUORIDATED WATER PROPOSED BY INITIATIVE PETITION FOR THEIR APPROVAL OR REJECTION AND DECLARING AN EMERGENCY..

WHEREAS, a general election as provided by the Charter of the City of Warrenton shall be held on the 6th day of November, A.D. 1956 for the election of three Commissioners and an Auditor and Police Judge, and

WHEREAS, the legal voters of the City of Warrenton have proposed by initiative petition an Ordinance prohibiting fluoridated water for the approval or rejection of the legal voters, and

WHEREAS, the entire City of Warrenton shall constitute two election precincts with the polling places at the Fire Station in the City of Warrenton and at the City Hall of the City of Warrenton, the address and boundary of these polls to be described later in this Ordinance, said polls to be open from eight o'clock in the morning until eight o'clock in the evening, without closing, as by the Charter provided;

NOW THEREFORE THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS: Section 1. That <u>Anna Tetlow</u>; <u>Helen M. Lenhard</u> and <u>Barbara Knotts</u> be and they are hereby appointed Judges and <u>Miriam Bronson</u>

and <u>Esther Birkholz</u> be and they are hereby appointed Clerks of the General election to be held in the City of Warrenton on the 6th day of November, 1956 and they are hereby ordered and directed to be present at the polling place of election precinct No. 1 which is hereby declared to be the Fire Station of the City of Warrenton and attend to the casting of ballots in said general election as by law provided.

Section 2. That the boundaries of election precinct No. 1 of the City of Warrenton shall be as follows: All lands in the City limits lying West of State Secondary Highway 104, commonly known as Main Street, except Block 9, Warrenton Addition, which is located in Precinct 2.

That the polling place of election precinct No. 1 is the Fire Station of the City of Warrenton located on Fourth Street in the City of Warrenton, Oregon.

Section 3. That Hazel Moore,

directed to be present at the polling place of Election precinct						
No. 2 which is hereby declared to be the City Hall of the City of						
Warrenton and attend to the casting of ballots in said General						
Election as by law provided.						

Section 4. That the boundaries of Election precinct No. 2 of the City of Warrenton shall be as follows: All the incorporated limits of the City of Warrenton lying East of Main Street, plus Block 9, Warrenton Addition, which is also included in Precinct 2. That the polling place of election precinct No. 2 is the City Hall of the City of Warrenton located on Main Street in the City of Warrenton, Oregon.

Section 5. That the Auditor and Police Judge is hereby ordered and directed to post notices of general election in three public places in each of the two election precincts in the City of Warrenton, Oregon which said notice shall notify the electors of the City of Warrenton of such general election, the officers to be elected, the Ordinance prohibiting fluoridated water proposed by Initiative Petition being submitted to the legal voters for their approval or rejection at said general election, the places of holding said election and the names of the Judges and Clerks of said election appointed for the same, which said notices shall be so posted by said Auditor and Police Judge for a period of ten days prior to the date set for such general election.

Section 6. At said election on the 6th day of November, 1956, there shall be submitted to the legal voters of the City of Warrenton for their approval or rejection the following Ordinance, to-wit:

An ordinance to prohibit the fluoridation of water, and/or the furnishing of fluoridated water, used and/or consumed or to be used and/or consumed by the citizens of the City of Warrenton, Oregon, and providing for violation of this act, and repealing all other ordinances, parts of ordinances, resolutions and/or other acts in conflict herewith, and declaring an emergency.

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any person to put fluoride and/or fluorine in any form in the water supply furnished to and/or for the citizens of the City of Warrenton, Oregon, and/or to place any such substance in such position that high water, natural seepage, and/or other causes will carry the same into any such waters.

Section 2. It shall be unlawful for any person to furnish and/or arrange for the furnishing of water for use and/or consumption by, through, and/or for the citizens of the City of Warrenton, to which said water has been added, installed, injected, infiltrated, induced, introduced, or otherwise combined, any and/or all forms of fluorine and/or fluoride.

Section 3. Any person violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not less than \$2.00 nor more than \$300.00, in the discretion of the Court; provided, that each and every day during which such person shall so violate this ordinance and/or permit the violation thereof, shall be deemed to be a separate and distinct offense.

Section 4. All ordinances, or parts of ordinances in conflict with this ordinance be and the same are hereby repealed.

WHEREAS, it is necessary that the presence of fluoride in the water supply of the City of Warrenton, Oregon be eliminated immediately, to protect the health and safety of the citizens of the City of Warrenton, Oregon, whose health and safety are now endangered thereby,

AN EMERGENCY is hereby declared to exist and this ordinance shall immediately go into force and effect from and after the date of its passage.

Section 7, That the following ballot title is hereby adopted for said Ordinance:

Section 8. That the Auditor and Police Judge shall cause the full text of the above described anti-fluoridation Ordinance and its ballot title and number to be printed in a newspaper published in the City of Warrenton, namely the Columbia Beacon, for two successive publications, not later than 15 days before said election.

An emergency is hereby declared to exist for the reason that the charter of the City of Warrenton states there shall be a general city election held on the 1st Tuesday after the first Monday of each year in November and it is necessary to elect three Commissioners and an Auditor and Police Judge to help govern the city in all financial matters and in all matters relating to the public health, peace, safety and welfare of the city, its residents, its citizens and its property and to carry out the wishes of the people proposed by initiative petition in regard to fluoridated water, and this ordinance shall go into force and effect immediately upon passage and approval.
