

ORDINANCE NO. 447A

AN ORDINANCE TO REGULATE MOTOR VEHICLE AND OTHER TRAFFIC BY ESTABLISHING A ONE HOUR PARKING LIMIT BETWEEN THE HOURS OF 12 NOON AND 8 O'CLOCK P.M. IN FRONT OF OREGON LIQUOR CONTROL COMMISSION STORE ON S.E. FIRST STREET BETWEEN MAIN AND S.E. ANCHOR IN THE CITY OF WARRENTON; AND BY ESTABLISHING A LOADING ZONE AT THE REAR OF THE BUILDING LOCATED AT 58 S.E. HARBOR ON S.E. FIRST STREET BETWEEN MAIN AND S.E. ANCHOR; AND BY ESTABLISHING MARKED CROSS WALKS AND DESIGNATING THEM UPON STREET AND HIGHWAY AREA BY PROPER MARKING SIGNS; AND PROVIDING THAT THIS ORDINANCE SHALL BE AN ADDITIONAL ORDINANCE TO ORDINANCE NO. 380-A; AND TO PROVIDE FOR OFFICIAL TRAFFIC SIGNS; AND TO PROVIDE A PENALTY FOR THE VIOLATION OF THIS ORDINANCE AND DECLARING AN EMERGENCY.

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That a one hour parking limit sign, consisting of a painted strip not over 22 feet in length, or other sign, signs or markers, be placed on the sidewalk or street, or both, in front of the Oregon Liquor Control Commission Store on S.E. First Street between Main and S. E. Anchor in the City of Warrenton.

Section 2. That motor vehicles and other vehicles are prohibited from parking in said designated one hour limit parking zone between the hours of 12 noon and 8 o'clock P.M., except Sundays and State of Oregon legal holidays.

Section 3. That loading zone sign, signs, strip or markers not over 22 feet in length be placed on the sidewalk or street or both at the rear of the building located at 58 S. E. Harbor on S. E. First Street between Main and S. E. Anchor.

Section 4. That motor vehicles and other vehicles are prohibited from entering or parking in said designated loading zone except for loading purposes.

Section 5. That all existing painted crosswalks on streets, highways or alleys of the City of Warrenton are hereby designated and established as marked crosswalks, and their exact location is hereby referred to and made a part of this Ordinance.

Section 6. That Ordinance No. 380-A be and is hereby affirmed and that this Ordinance be and is hereby made an additional Ordinance


regulating motor vehicle traffic.

Section 7. That every person convicted of violating any of the provisions of this Ordinance shall be punished by a fine of not more than \$300.00 or by imprisonment in the city jail of not more than 150 days. PROVIDED, HOWEVER, no person shall be penalized by fine or imprisonment more than set out in Oregon Revised Statutes as set out in Warrenton Ordinance No. 380A.

Section 8. That inasmuch as it is advisable to provide immediate protection because of congested summer traffic by establishing the afore-described one hour parking limit and the afore-described loading zone and the afore-described marked cross walks for the health, peace and safety of the residents of the City of Warrenton, it is deemed necessary that an emergency be and the same is hereby declared to exist, and this Ordinance shall become immediately operative upon its passage by the City Commission.
