

ORDINANCE NO. 474A

AN ORDINANCE ADDING TO AND AMENDING ORDINANCE NO. 448A ENTITLED "AN ORDINANCE TO REGULATE TRAFFIC, ETC." AND REPEALING CERTAIN PARTS OF ORDINANCE 448A AND GIVING THEIR EFFECTIVE DATES AND DECLARING AN EMERGENCY

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. The following enumerated statutes, chapters and laws of State of Oregon Session Laws of 1965 which amend and add to Ordinance No. 448A entitled "AN ORDINANCE TO REGULATE TRAFFIC, ETC." and repeal certain parts thereof, are hereby adopted by reference and made a part of this Ordinance:

Section 2. All acts which are made unlawful by the above mentioned statutes, chapters and laws of the State of Oregon Session Laws of 1965 shall be considered as offenses against the City of Warrenton when committed within its boundaries and shall be punished by the penalties provided in said statutes, chapters and laws of the State of Oregon Session Laws of 1965 and the penalties provided in ORS statutes as set out in Ordinance No.448A, save and except no fine shall exceed \$300.00 and no imprisonment shall exceed 150 days and both fine and imprisonment may be imposed, but in no event shall penalties exceed the penalties provided in Oregon Revised Statutes as set out in Ordinance No. 448A and the penalties set out in 1965 Oregon Session Laws which are set out in this Ordinance.

Page Two, Ordinance.

Section 3. Inasmuch as it is necessary to provide the means whereby the Municipal Court shall have jurisdiction over violations of traffic laws for the health, peace and safety of the residents of the City of Warrenton, and Whereas the City has been formerly using State Motor Vehicle Traffic Laws set out in Oregon Revised Statutes, and Whereas Oregon Revised Statutes have been supplemented, amended, repealed and rescinded as to certain sections of the Motor Vehicle Code by the 1965 Oregon Session Laws and the present City Ordinance to regulate motor vehicle traffic needs to be brought up to date, it is deemed necessary that an emergency be and the same is hereby declared to exist and this Ordinance shall become immediately operative from and after its passage by the City Commission.
