AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR, CITY COMMISSIONERS AND AUDITOR AND POLICE JUDGE TO MAKE, EXECUTE AND DELIVER A DEED TO EDWARD J. SALMI AND ELMER R. SALMI, NOT AS TENANTS IN COMMON BUT WITH RIGHT OF SURVIVORSHIP FOR THE PURPOSE OF CLEARING THEIR TITLE

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That the Mayor, City Commissioners and Auditor and Police Judge be and they are hereby authorized and directed to make, execute and deliver a Deed to Edward J. Salmi and Elmer R. Salmi, not as tenants in common but with right of survivorship,

to the following described real property:

The Easterly 15 feet of that part of N. E. Bay Avenue, formerly Water Street in the City of Warrenton, County of Clatsop and State of Oregon, vacated by Ordinance No. 407A of the City of Warrenton, a certified copy of No. 407A of the City of marrenton, a certified copy of said Ordinance being recorded on April 20, 1960 in Book 254, instrument No. 206977, Deed Records Clatsop County, Oregon, more particularly described as follows: Beginning at the Northeasterly corner of Lot 5, Block 117, SECOND EXTENSION OF WARRENTON, in the City of Warrenton, County of Clatsop and State of Oregon; thence Easterly along the Easterly extension of the Northerly line of said Lot 5 a distance of 45 feet to

for the purpose of clearing title.
