

ORDINANCE NO. 491 A

AN ORDINANCE LEVYING TAXES FOR GENERAL MUNICIPAL PURPOSES FOR THE CITY OF WARRENTON FOR THE FISCAL YEAR COMMENCING AS OF JULY 1, 1967 AND ENDING JUNE 30, 1968 UPON SAID FISCAL TAX ROLL, CONFIRMING, APPROVING AND ADOPTING THE BUDGET AS PREPARED, SUBMITTED AND ACTED UPON BY THE LEVYING BOARD AND THE BUDGET COMMITTEE OF THE CITY OF WARRENTON AND MAKING APPROPRIATIONS AND DECLARING AN EMERGENCY.

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That there be and is hereby levied a tax for general municipal purposes for the City of Warrenton for the fiscal year of July 1, 1967 to June 30, 1968, inclusive, upon said fiscal tax roll the sum of \$36,767.00, and that said tax as aforesaid is hereby declared levied upon all of the taxable property within the city limits of the City of Warrenton, Clatsop County, State of Oregon.

Section 2. That the budget for general municipal expenses and purposes for the City of Warrenton for the fiscal year of July 1, 1967 to June 30, 1968, inclusive, upon said fiscal year tax roll, as prepared, submitted and adopted by the levying board and Budget Committee of the City of Warrenton be and the said budget is hereby approved, confirmed and adopted and is hereby referred to and made a part of this tax levying Ordinance as though set out in full herein.


Section 3. That the amounts for the fiscal year beginning July 1, 1967 to and including June 30, 1968 and for the purposes shown below are hereby appropriated as follows:

Section 4. That the Auditor and Police Judge of the City of Warrenton be and is hereby directed to notify in writing the County Assessor and the County Clerk of Clatsop County, State of Oregon of the amount of money proposed to be raised by taxation, not later than the 15th day of July, 1967, accompanied by a true copy of the Budget as finally adopted to each, and shall file with the State Treasurer and the Division of Audits of the Secretary of State a true copy of the Budget as finally adopted.

. An emergency is hereby declared to exist for the reason that the City would be without funds to operate its fire and police departments and fix its dykes or perform any municipal functions without the passage of this Ordinance promptly, and this Ordinance shall go into force and effect immediately upon passage and approval.
