

ORDINANCE NO. 493 A

AN ORDINANCE TO REGULATE MOTOR VEHICLE AND OTHER TRAFFIC BY ESTABLISHING STOP SIGNS AT SOUTHWEST ELEVENTH STREET WHERE IT INTERSECTS WITH THE SP&S RAILWAY CROSSING AND ON BOTH SIDES OF THE TRACK; AND BY ESTABLISHING A STOP SIGN ON THE SOUTHEAST CORNER OF THE INTERSECTION OF SOUTHWEST MAIN COURT AND SOUTHWEST SECOND STREET IN THE CITY OF WARRENTON, PROHIBITING CROSSING WITHOUT STOPPING AT SAID POINTS AND PROVIDING FOR OFFICIAL TRAFFIC SIGNS AND PROVIDING A PENALTY FOR VIOLATION THEREOF.

WHEREAS, the SP&S Railway track intersection with Southwest Eleventh Street and the intersection of Southwest Second Street with Southwest Main Court are dangerous intersections with regard to vehicular traffic, and

WHEREAS, there are no City or State "Stop" signs located at said intersections, and

WHEREAS, It is for the public health and safety of the residents of the City of Warrenton that said "Stop" signs be erected on both sides of the SP&S Railway crossing where it intersects with Southwest Eleventh Street, and that a "Stop" sign be erected on the Southeast corner of the intersection of Southwest Second Street and Southwest Main Court,

NOW THEREFORE THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That "Stop" signs be placed on both sides of the intersection of the SP&S Railway crossing at Southwest Eleventh Street, and that motor vehicles and other vehicles are prohibited from crossing said intersection without making a complete stop before crossing the SP&S Railway track where it intersects with Southwest Eleventh Street and on both sides of the railroad track.

Section 2. That a "Stop" sign be erected on the Southeast corner of the intersection of Southwest Second Street and Southwest Main Court and that motor vehicles and other vehicles are

prohibited from crossing said intersection without making a complete stop at the Southeast corner of the said intersection.


Section 3. That Ordinance No. 493A be and hereby is made an additional Ordinance regulating motor vehicle traffic.

Section 4. That the placing of official traffic signs consisting of "Stop" signs at said intersections above described be and is hereby authorized.

Section 5. That every person convicted of violating any of the provisions of this Ordinance shall be punished by a fine of not more than \$150.00 or by imprisonment in the City jail of more than fifty (50) days. For a second or subsequent conviction within one year thereafter, such person shall be punished by a fine of not more than \$300.00 or by imprisonment in the City jail of not more than one hundred fifty (150) days, or by both such fine and imprisonment.
