AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR, CITY COMMISSIONERS AND AUDITOR AND POLICE JUDGE TO MAKE, EXECUTE AND DELIVER A DEED TO LEWIS & CLARK LUMBER CO., a NEVADA CORPORATION, FOR THE SUM OF TWO HUNDRED FIFTY ONE THOUSAND AND NO/100 DOLLARS.

THE CITY OF WARRENTON DOES ORDAIN AS FOLLOWS:

Section 1. That the Mayor, City Commissioners and the Auditor and Police Judge be and they are hereby authorized and directed to make, execute and deliver a deed to Lewis & Clark Lumber Co., a Nevada corporation, to the following described real property:

"All the lands, tidelands, water frontage and wharfing and riparian rights situated in the County of Clatsop, State of Oregon, and more particularly bounded and described as follows, to-wit:

PARCEL NO. 1:
